Beskrywing

Die noordelike terminaal van Maclear se meridiaanboog, tesame met die dorsvloer, geleë op 'n gedeelte van Gedeelte 9 van die plaas Klipfontein 103 in die administratiewe distrik Piketberg, en groot 330 (driehonderd-en-dertig) vierkante meter soos aangedui deur die figuur ABCDEF op Landmeterskaart LG 297-94, gedateer 16 Februarie 1994, geliasseer in die kantoor van die Landmeter-generaal in Kaapstad en op Lêer 9/2/072/2 in die kantoor van die Raad vir Nasionale Gedenkwaardighede in Kaapstad.

**DECLARATION OF PROPERTIES TO BE
NATIONAL MONUMENTS**

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act No. 28 of 1969), I, Baldwin Siphon Ngubane, Minister of Arts, Culture, Science and Technology, hereby declare the properties as fully described in the Schedule hereto to be national monuments.

SCHEDULE

1. THE NORTHERN TERMINAL OF MACLEAR'S ARC OF MERIDIAN, TOGETHER WITH THE TRESHING FLOOR, ON THE FARM KLIPFONTEIN, DISTRICT OF PIKETBERG 9/2/072/2 ✓

Description

The northern terminal of Maclear's Arc of Meridian, together with the threshing floor, situated on a portion of Portion 9 of the farm Klipfontein 103 in the Administrative District of Piketberg, in extent 330 (three hundred and thirty) square metres as indicated by the figure ABCDEF on Surveyor's Diagram SG 297-94, dated 16 February 1994, filed in the office of the Surveyor General in Cape Town and on File 9/2/072/2 in the office of the National Monuments Council in Cape Town.

2. THE FAIRFELL HOMESTEAD WITH TEN METRES OF SURROUNDING LAND, SITUATED ON SUBDIVISION 2 OF ERF 755, HOWICK 9/2/417/3

Description

The Fairfell homestead with ten metres of surrounding land, situated on Subdivision 2 of Erf 755, Howick, in the Borough of Howick, County of Pietermaritzburg, Province of Natal.

3. THE WALLS OF THE TWO RESERVOIRS BELOW THE PRESENT DE WAAL PARK, GARDENS, CAPE TOWN 9/2/018/13

Description

The walls of the two reservoirs below the present De Waal Park, situated on a piece of unregistered State land, being a portion of Erf 95129, Cape Town, in the Municipality of Cape Town.
