VERKLARING TOT 'N KULTUURSKAT: DIE VOORTREKKERPREEKSTOEL, TANS IN DIE VOORTREKKERMUSEUM, PIETERMARITZBURG

Kragtens artikel 5 (1) (cD) van die Wet op Nasionale Gedenkwaardighede, 1969 (Wet No. 28 van 1969), verklaar die Raad vir Nasionale Gedenkwaardighede hierby die Voortrekkerpreekstoel, soos in die Bylae hiervan meer volledig beskryf en wat tans in die Voortrekkermuseum te Pietermaritzburg gehuisves word, tot 'n kultuurskat vanweë die kultuur-historiese en estetiese belang daarvan.

BYLAE

Die Voortrekkerpreekstoel is tussen 1840 en 1841 deur ene Nagel en Heine, in die eerste jaar van die Geloftekerk se bestaan, van verskillende plaaslike houtsoorte vervaardig. In 1861 is dit na die nuwe Voortrekkerkerk verskuif, maar dit is weer in 1955 in die Geloftekerk, tans die Voortrekkermuseum, teruggeplaas. Hierdie neo-Gotiese agtkantige preekstoel van vier meter hoog, bestaan uit drie dele, naamlik die voetstuk, die lessenaar en die baldakyn.

DECLARATION OF A CULTURAL TREASURE: THE VOORTREKKER PULPIT, PRESENTLY IN THE VOORTREKKER CHURCH, PIETERMARITZBURG

In terms of section 5 (1) (cD) of the National Monuments Act, 1969 (Act No. 28 of 1969), the National Monuments Council hereby declares the Voortrekker pulpit, as fully described in the Schedule hereto and which is presently housed in the Voortrekker Museum, at Pietermaritzburg, to be a cultural treasure on account of the cultural-historical and easthetic importance thereof.

SCHEDULE

The Voortrekker pulpit was manufactured from various local timbers between 1840 and 1841 by Nagel and Heine, in the first year after the establishment of the Church of the Vow. In 1861 it was moved to the new Voortrekker church, but it was returned to the Church of the Vow, now the Voortrekker Museum, in 1955. This neo-Gothic octagonal pulpit which is four metres high, consists of three parts, being the plinth, the lectern and the canopy.
