Kragtens artikel 5 (1) (cD) van die Wet op Nasionale Gedenkwaardighede, 1969 (Wet No. 28 van 1969), verklaar die Raad vir Nasionale Gedenkwaardighede hiermee die kanonne bekend as Castor en Pollux, beide 6,3 duim RML howitzers, en soos in die Bylae hiervan meer volledig beskryf, tot kultuurskatte vanweë die historiese en kulturele belang daarvan.

BYLAE

Die twee kanonne bekend as Castor en Pollux is tydens die Beleg van Ladysmith (2 November 1899–28 Februarie 1900) gebruik. Op 27 November 1899 is die kanonne na Wagon Hill (ook bekend as Platrand) geneem waar dit teen 'n Long Tom-kanon aan Boerekant in aksie was. Op 18 Desember 1899 is die Castor-kanon beskadig, maar dit is op die slagveld herstel. Die Castor- en Pollux-kanonne het 765 van die 800 beskikbare rondtes ammunisie gevuur. Albei kanonne is daarna voor die Stadsaal van Ladysmith geplaas.

CASTOR AND POLLUX, 6,3 INCH RML
HOWITZER GUNS**

In terms of section 5 (1) (cD) of the National Monuments Act, 1969 (Act No. 28 of 1969), the National Monuments Council hereby declares the guns known as Castor and Pollux, both 6,3 inch RML howitzers, as more fully described in the Schedule hereto, to be cultural treasures because of their historical and cultural importance.

SCHEDULE

The two guns known as Castor and Pollux were used during the Siege of Ladysmith (2 November 1899–28 February 1900). On 27 November 1899 the guns were taken to Wagon Hill (also known as Platrand) where they were engaged in a battle with a Boer Long Tom gun. The Castor gun was damaged on 18 December 1899, but was repaired on the battlefield. The Castor and Pollux guns fired 765 of the 800 available rounds of ammunition. Both guns have subsequently been placed in front of the Town Hall of Ladysmith.

In terms of section 5 (1) (cD) of the National Monuments Act, 1969 (Act No. 28 of 1969), the National Monuments Council hereby declares the so-called One

hierby die sogenaamde "One O'Clock 12PR ML"-Vlootkanon te Pietermaritzburg, en soos in die Bylae hiervan meer volledig beskryf, tot kultuurskat vanweë die historiese en kulturele belang daarvan.

BYLAE

Hierdie kanon is in 1812 vervaardig en in 1840 op die "HMS Fawn", wat aanvanklik vir die agtervolging van slaweskepe gebruik is, gemonteer. Ná die beleg van Port Natal in 1842 is die "HMS Fawn" daarheen gestuur om dié nedersetting te verdedig. Die kanon is ongeveer twee jaar later na Fort Napier in Pietermaritzburg verskuif, waar dit as die "One O'Clock Gun" bekend geraak het vanweë die feit dat dit elke dag (Sondae uitgesluit) om eenuur afgevuur is. Die kanon is weer in 1879 vir die verdediging van Pietermaritzburg gebruik, waarna dit na die huidige posisie oorkant die Stadsaal verskuif is.

O'Clock 12PR ML Naval Gun at Pietermaritzburg, as more fully described in the Schedule hereto, to be a cultural treasure because of its historical and cultural importance.

SCHEDULE

This gun was manufactured in 1812 and was fitted in 1840 to the HMS Fawn, which was originally used for pursuing slave ships. After the siege of Port Natal in 1842 the HMS Fawn was sent to protect this settlement. About two years later the gun was moved to Fort Napier at Pietermaritzburg, where it became known as the "One O'Clock Gun", due to it being fired at one o'clock each day (except Sundays). After being used again in the defence of Pietermaritzburg in 1879, the gun was moved to its present position opposite the City Hall.
