Certain piece of redeemed quitrent land situate in the Municipality of Noupoot, Division of Colesberg, being the remainder of Erf 91, Noupoot, with the historic Anglican Church thereon and measuring 674 (Six hundred and seventy-four) square metres.

*Historical and architectural interest*

The stone church in the neo-Gothic style was erected in 1901 by British troops, who had their headquarters at Noupoot, and is intimately associated with the history of the town. 10/2/522.
