DECLARATION OF PROPERTIES TO BE
NATIONAL MONUMENTS

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Louis Alexander Pienaar, Minister of National Education, hereby declare the properties as fully described in the Schedule hereto to be national monuments.

SCHEDULE

**1. THE FAÇADE OF THE BUILDING COMPLEX
KNOWN AS THE INN ON THE SQUARE
SITUATED ON GREENMARKET SQUARE, CAPE
TOWN**

Description

The façade of the building complex known as the Inn on the Square, situated on the following erven:

- (i) Certain piece of land, situated in Blok J.J. on Greenmarket Square, Cape Town, in the City of Cape Town, Division of the Cape, being the remainder of Erf 2360, Cape Town, at Cape Town;
- (ii) certain piece of land, situated as above, in Blok J.J., being Erf 2361, Cape Town, at Cape Town;
- (iii) certain piece of land, situated as above, in Blok J.J., being Erf 2358, Cape Town, at Cape Town;
- (iv) certain piece of land, situated as above, in Blok J.J., being Erf 2357, Cape Town, at Cape Town; and
- (v) certain piece of land, situated as above, in Blok J.J., being Erf 2356, Cape Town, at Cape Town.

**2. THE HISTORIC POLICE STATION BUILDING ON
THE CORNER OF LOOP STREET AND MURRAY
LANE, PIETERMARITZBURG**

Description

The historic police station building, situated on a certain piece of land formerly known as the Erf 23, Loop Street (now known as Erf 2623, Pietermaritzburg) situated in City of Pietermaritzburg, Province of Natal.

**3. THE PROPERTY WITH THE TAFELBERG
DUTCH REFORMED CHURCH COMPLEX
THEREON, CONSISTING OF THE CHURCH
BUILDING, THE CORNELIA HOUSE AND THE
WILLIAM FREDERICK SCHOOL BUILDING,
SITUATED ON THE CORNER OF BUITENKANT
AND COMMERCIAL STREETS, CAPE TOWN**

Description

The property together with the Tafelberg Dutch Reformed Church Complex thereon, consisting of the church building, the Cornelia House and the William Frederick school building, described as follows:

- (i) The remainder of Erf 5314, situated in the City of Cape Town, Division of the Cape, in extent 607 (six hundred and seven) square metres.
