A TOWNSHIP

The State President has, in terms of section 184 of the Mining Rights Act, 1967 (Act 20 of 1967), reserved for purposes of a township a portion of proclaimed land held under mining title, approximately 11,780 3 hectares in extent, situate on the farm Doornfontein 92 IR, District of Johannesburg, Mining District of Johannesburg, Province of the Transvaal, registered in the name of City Deep Limited and as shown on a sketch plan, copies of which have been filed in the Mining Titles Office, Johannesburg, and in the office of the Mining Commissioner, Johannesburg, under RMT No. R9/76.

DECLARATION OF A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Pieter Gerhardus Jacobus Koornhof, Minister of National Education, hereby declare the historic mission house at Hermannsburg, with 20 metres of surrounding land, situate on the farm Remainder of Perseverance 1324, near Kranskop, Natal, to be a national monument.

Description

The historic mission house at Hermannsburg, with 20 metres of surrounding land, being situate on the farm Remainder of Perseverance 1324 near Kranskop in the Province of Natal, and measuring as such 2 150,8036 hectares.

Deed of transfer 92/1885, dated 10 February 1885.

Historical and architectural interest

The historic mission house at Hermannsburg was erected around 1862 in the German-Saxon style, in order to provide housing for the staff of the Hermannsburg Mission Station. This building is probably the only German-Saxon house in South Africa, 10/2/445.

Historiese en argitektoniese belang

Die historiese sendinghuis te Hermannsburg is in ongeveer 1862 in die Duits-Saksiese styl gebou om huisvesting te verskaf aan die personeel van die Hermannsburg-sendingstasie. Hierdie gebou is vermoedelik die enigste Duits-Saksiese huis in Suid-Afrika, 10/2/445.
