NATIONAL MONUMENTS ACT, No. 28 OF 1969

DECLARATION OF THE MAGISTRATE'S OFFICE
BUILDING, UTRECHT, NATAL

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act 28 of 1969), I, Pieter Gerhardus Jacobus Koornhof, Minister of National Education, hereby declare the historic magistrate's office building, together with 10 metres of surrounding land, at Utrecht, Natal, to be a national monument.

Description

The historic magistrate's office building, together with 10 metres of surrounding land, situate on a portion of Erf 190, Utrecht, and in extent four point five eight three three (4.5833) morgen.

Crown Grant 6705/1904, dated 9 December 1904.

Historical and architectural interest

The magistrate's office building was erected between 1894 and 1899 by the Government of the "Zuid-Afrikaansche Republiek". 10/2/569.
