DECLARATION OF THE PROPERTY KNOWN AS PORTION "C" OF ERF 97 WITH THE DWELLING-HOUSE THEREON, SITUATED IN TOBIE MULLER STREET, PHILIPPOLIS

By virtue of the powers vested in me by section 10 (1) of the War Graves and National Monuments Act, 1969 (Act 28 of 1969), I, Pierre Cronjé, Deputy Minister of National Education, hereby declare the property known as Portion "C" of Erf 97, Philippolis, with the dwelling-house thereon, more fully described below, to be a national monument.

Description

The property with the dwelling-house thereon, being certain Portion "C" of Erf 97, situated in the Township and District of Philippolis, in extent 150 (one hundred and fifty) square metres.

Deed of Transfer T7763/1978, dated 19 October 1978.

Architectural interest

This dwelling-house is a fine example of the flat-roofed type which from the late fifties of the nineteenth century replaced the houses with steep thatched roofs in the Orange Free State and which represents the most characteristic building type of the early Republican period. It is also an example of the earliest town houses which have been preserved in the Orange Free State. (RNG 10/2/1165.)

Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Oorlogsgrafe en Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Pierre Cronjé, Adjunk-minister van Nasionale Opvoeding, hierby die eiendom bekend as Gedeelte "C" van Erf 97, Philippolis, met die woonhuis daarop, soos hieronder vollediger beskryf, tot nasionale gedenkwaardigheid.

Beskrywing

Die eiendom met die woonhuis daarop, synde sekere Gedeelte "C" van Erf 97, geleë in die dorp en distrik Philippolis, groot 150 (eenhonderd-en-vyftig) vierkante meter.

Argitektoniese belang

Hierdie woonhuis is 'n mooi voorbeeld van die platdak-tipe wat van die laat vyftigerjare van die neentiende eeu af die huise met steil grasdakke in die Oranje-Vrystaat vervang het en wat die kenmerkendste boutype van die vroeë Republikeinse tydperk verteenwoordig. Dit is ook 'n voorbeeld van die vroegste dorps huise wat in die Oranje-Vrystaat behoue gebly het. (RNG 10/2/1165.)
