WAR GRAVES AND NATIONAL MONUMENTS ACT,
No. 28 OF 1969DECLARATION OF THE PROPERTY WITH THE
DWELLING-HOUSE THEREON, SITUATED AT 24
TOBIE MULLER STREET, PHILIPPOLIS

By virtue of the powers vested in me by section 10 (1) of the War Graves and National Monuments Act, 1969 (Act 28 of 1969), I, Pierre Cronjé, Deputy Minister of National Education, hereby declare the property known as certain Portion "P" of Erf 101, Philippolis, with the dwelling-house thereon, more fully described below, to be a national monument.

Description

The property with the dwelling-house thereon, being certain Portion "P" of Erf 101, situated in the Township and District of Philippolis, in extent 408 (four hundred and eight) square metres.

Deed of Transfer T7758/1979, dated 30 August 1979.

Architectural interest

This dwelling-house is a fine example of the flat-roofed type which from the late fifties of the nineteenth century replaced the houses with steep thatched roofs in the Orange Free State and which represents the most characteristic building type of the early Republican period. It is also an example of the earliest town houses which have been preserved in the Orange Free State. (RNG 10/2/1163.)

Kragtens die bevoegdheid my verleen by artikel 10 (1) van die Wet op Oorlogsgrafte en Nasionale Gedenkwaardighede, 1969 (Wet 28 van 1969), verklaar ek, Pierre Cronjé, Adjunk-minister van Nasionale Opvoeding, hierby die eiendom bekend as sekere Gedeelte "P" van Erf 101, Philippolis, met die woonhuis daarop, soos hieronder vollediger beskryf, tot nasionale gedenkwaardigheid.

Beskrywing

Die eiendom met die woonhuis daarop, synde sekere Gedeelte "P" van Erf 101, geleë in die dorp en distrik Philippolis, groot 408 (vierhonderd-en-agt) vierkante meter.

Transportakte T7758/1979, gedateer 30 Augustus 1979.

Argitektoniese belang

Hierdie woonhuis is 'n mooi voorbeeld van die platdak-tipe wat van die laat vyftigerjare van die neëntiende eeu af die huise met steil grasdakke in die Oranje-Vrystaat vervang het en wat die kenmerkendste boutipe van die vroeë Republikeinse tydperk verteenwoordig. Dit is ook 'n voorbeeld van die vroegste dorpshuise wat in die Oranje-Vrystaat behoue gebly het. (RNG 10/2/1163.)
