DECLARATION OF PROPERTY TO BE A NATIONAL MONUMENT

By virtue of the powers vested in me by section 10 (1) of the National Monuments Act, 1969 (Act No. 28 of 1969), I, Lionel Percival Hercules Mbeki Mtshali, Minister of Arts, Culture, Science and Technology, hereby declare the properties as fully described in the Schedule hereto to be national monuments.

 THE HOUSE AT 1225 FELIX STREET, MOUNTAIN VIEW, PRETORIA Description

The house situated on the remainder of Portion 20 of Erf 376, Mountain View, Registration Division JR, Gauteng.

2. THE PROPERTY WITH THE OLD MAGISTRATE'S OFFICE THEREON, IN WAKKERSTROOM Description

The property with the Old Magistrate's Office thereon, being Portion 1 of Erf 150, Marthinus Wesselstroom (also known as Wakkerstroom), Registration Division HT, in extent 3 394 (three thousand three hundred and ninety-four) square metres.
