By virtue of the powers vested in Heritage Western Cape, as the provincial heritage resources authority for the province of the Western Cape, in terms of section 27 of the National Heritage Resources Act, Act no. 25 of 1999, archaeological and palaeontological sites, unmarked burials, the landscape and natural features of cultural significance and structures situated on or at Farm 1223 in the division of Malmesbury, Hopefield District, known as the West Coast Fossil Park, and as surveyed and reflected in the diagram S.G. 1154/2010 held at the offices of the Surveyor General and covering 830,4981 hectares in extent, are hereby formally protected under Section 27 of the Act bearing the provisions of Sections 34, 35 and 36 of the Act in mind

Significance

The West Coast Fossil Park at Langebaanweg is a five million year old fossil bed that was discovered in the floor of an open cast phosphate mine in the 1960s. Since then, researchers at the Iziko: South African Museum have amassed over one million vertebrate fossils from controlled excavations, surface collecting and bulk sampling in different parts of the mine. These fossils have achieved international acclaim by scientists for their superb preservation, abundance and richness in diversity to the extent that this locality is now widely regarded as possibly the most important Early Pliocene terrestrial fossil occurrence in the world.

The previous declaration of this site in terms of Government Notice 17457, dated 4 October 1996 is hereby withdrawn

Significance

De Hel is a heritage site with historical and archaeological value and is a landscape of high cultural significance. The site is a surviving remnant of a natural forest in this region where the Dutch East India Company (VOC) had a woodcutter's post at Witte Boomen (Wittebome). The site has links to ancient cattle tracks established by Khoekhoe pastoralists. It also has archaeological heritage resources dating from this period and may have unmarked burials.

Betekenis

Die Weskus Fossielpark by Langebaanweg is 'n navorsings- en paleotoerisme-onderneming by 'n 5-miljoenjaar oue fossielbed wat in die 1960s in die vloer van 'n oopkrag fosfaatmyn ontdek is. Sedertdien het navorsers van Iziko: Suid-Afrikaanse Museum meer as 'n miljoen gewerwelde fossiele uit beheerde uitgrawings, oppervlakversameling en grootmaat-steekproewe uit verskillende gedeeltes van die myn versamel. Hierdie fossiele het internasionale status verwerf vanweë hulle uitstekende bewaring, hoë voorkomsfrekwensie en rykheid in diversiteit, in so 'n mate dat hierdie terrein nou grootliks as waarskynlik die wêreld se belangrikste Vroeë Plioseen-aardfossielterrein beskou word.

IDe Hel isisiza selifa lemveli esinexabiso ngokwembali nangokwe-akhiyoloji kwaye sinembonakalo-mhlaba ebaluleke kakhulu ngokwenkcubeko. Esi siza sesokugqibela esiseleyo samahlathi endalo kulo mmandla apho iDutch East India Company (VOC) yayinesikhululo somcandi-zinkuni esasiseWitte Boomen (Wittebome). Esi siza sasayamene nomzila weenkomo owawusungulwe ngabelusi bamaKhoekhoe. Ikwawo namaziko e-akhiyoloji elifa lemveli asusela kweli xesha likhankanyiweyo kwaye anokubanawo namangcwaba angaphawulwanga
