

Raw effluent flow into water sources overlooked

number of earlier oversights by the Democratic Alliance (DA) in Limpopo have discovered that raw effluent continued to flow from unattended disabled sewerage plants into rivers, ponds and water sources in several municipalities including Sekhukhune District Municipality (SDM)'s Elias Motsoaledi, Fetakgomo Tubatse and Ephraim Mogale local municipalities.

In a statement released on Tuesday, 08 November 2022, the DA said that responses to parliamentary questions, that revealed that SDM has ignored directives from the Department of Water and Sanitation (DWS) to clean up their act, was appalling.

The party indicated that according to responses to written questions to the Minister of Water and Sanitation, Senzo Mchunu, the SDM was given directives, following inspections, to immediately attend to the non-compliance of Sections 19 (3) and 53 (1) of the National Water Act (NWA), 1998, which was an offence in terms of Section 151 (1) (d) of the NWA at the Dennilton Waste Water Plant in Moutse.

Lindy Wilson, DA Political Head for Citrus Valley Constituency, said that the department has since laid criminal charges

against the SDM.

Wilson added that the directives issued on the Moganyaka oxidation ponds and Ephraim Mogale Waste Water Plant have also been ignored by the district municipality, which resulted in contamination of water and rivers, and seriously affected the health of people living in the local municipality.

She said that Lepelle Northern Water, responsible for the operation of four key waste water plants, has also clearly been negligent and that the Green Drop Scores for the plants have dropped drastically.

"The DA will revisit these plants shortly and should there be no indication that the directives issued by the DWS have not been adhered to, criminal charges will be laid by the DA," charged Wilson.

Wilson further said that they were concerned that the South African Human Rights Commission (SAHRC), to whom those water issues were presented during a commission of enquiry more than a year ago, has yet to respond.

"This is too problematic and it appears that very little attention is being given to the plight of the people in these municipalities. We will not back down from the fight for basic human rights for all citizens. We take the plight of the already suffering poor and vulnerable very

seriously," concluded Wilson.

In response, the SDM said it acknowledged receipt of notices of intention to issue directives as well as directives for non-compliance with Section 19 (3) and 53 (1) of the NWA, Act number 36 of 1998 for engaging in water use activities that were likely to cause pollution of a water resource and without authorization from the DWS.

Khomotso Ndlovu, SDM Acting Communications Manager, said that the municipality has responded to all the notices of intentions as well as directives indicating corrective measures and steps to be taken to address the non-compliance matters.

Ndlovu added that SDM has engaged LNW to assist in ensuring that the Waste Water Treatment Works complied with the required conditions and further that the LNW assisted in applications of the Water Use License for various plants.

"Pumps for Dennilton sewer pump station have been procured and delivered. Municipal honey-suckers have drained the blocked manhole, which stopped spillages. Monitoring of the functionality of the fat traps on Moutse Mall, consumers have been undertaken to ensure compliance as blockages of the manhole and pipes are caused by fats from

Moutse Mall. Engagements with Moutse Mall Management took place to highlight steps to be taken by the municipality to ensure compliance. Regarding laying of criminal charges against SDM by the DWS, we are unaware of such," concluded Ndlovu.

Yolande Nel, LNW Media Liaison Officer, said that LNW was not operating plants allegedly discharging raw sewage into sources within Sekhukhune district.

"We are operating Marble Hall, Groblersdal, Steelpoort and Burgersfort waste water treatment works," informed Nel.

he Economic Freedom Fighters (EFF) in Limpopo said it has noted with utter disgust the closure of a Post Office at Ga-Nchabeleng village under FetaKgomo Tubatse local Municipality (FTLM), in Apel by an ANC Ward 36 Cllr Matilda Tlape who locked the facility and took away the keys with her since April 2021 to date.

"Despite numerous attempts own," by the Ga-Nchabeleng Traditional Authority to

recover the keys, Tlape is adamant and hell-bent on bringing the Postal services to an GaNchaheleng abrupt halt permanently, thus impinging on service delivery, said EFF coordinator Rebecca Mohlala.

"Her obsession and entitlement to the position of administrator at the Post Office is mind blogging and thick-headed," she said.

Mohlala said postal services have been severely interrupted. "This includes the SASSA pay point services as old age grant beneficiaries cannot access the Post Office which was used as a pay point and as a result pensioners are forced to walk more than 7 kilometres to the nearby shopping complex so that they can withdraw their reopening of the Post Office, grant payments on a monthly basis," explained Mohlala.

She said both the Department of Social Development and Provincial Post Office management are aware of the debacle but intervention is not forthcoming, even though the anomaly persists for more than a year.

Meanwhile a member of Provincial Legislature (MPL) Winnie Mphahlele said the facility is currently under attack by criminals who are vandalising it and stealing electricity cables from it

Winnie added that the Department Social Development and Post Office have exhibited negligence, weakness and mediocrity in providing services to the residents of Ga-Nchabeleng

The official opposition party in the province said the facility only has two ambulances, of which the ambulances were borrowed from Mecklenburg Hospital

"It is now in the public domain that quality basic service delivery remains a fantasy in Ga-Nchabeleng. The EFF calls for a speedy intervention by the relevant departments," said Winnie.

"We demand the immediate secondly the department of Health must provide ambulances and medication to the above mentioned health centre," she concluded.

MARBLE HALL - A 50 yearold man has been sentenced to 54 years direct imprisonment by the Siyabuswa Regional Court for a spate of rape offences and housebreaking with intent to rape between 2013 and 2018.

According to police, the 50 year-old Papanyana Mike Kolobe began terrorizing the Siyabuswa community outside Marble Hall in 2013 when he pounced on a helpless victim aged 23. It is alleged that in January 2013, the victim was asleep on a couch when she was ordered to undress and subsequently raped on three counts. Police said that in July 2014, the accused went to another victim, a 32 year-old woman who was walking on the street from church at Ga-Phahla Village outside Marble Hall. He approached her from behind

Shushumela man hacks wife to death

SHUSHUMELA - A 47-year-old man was arrested after he allegedly hacked his wife to death with a panga at the Shushumela Informal Settlement outside Marble Hall. The brutal murder occurred on Sunday 6 November.

According to Colonel Malesela Ledwaba, Limpopo Provincial Police Spokesperson, said the suspect was arrested on Monday 7 November after he handed himself to the Lydenburg Police Station, about 150kms from where the murder incident happened.

"The suspect is alleged to be informing the Lydenburg Police about the incident, confessing to commit a murder of his wife and locked her inside the house. The Elandskraal Police were immediately summoned to the scene and discovered the body of the deceased with multiple body injuries and a panga next to it. The deceased was identified as Moloto Winifred Mabotja (41)," Ledwaba said.

Ledwaba said a case of murder has been opened and the motive of the incident is unknown, however, domestic violence cannot be ruled out.

Mabotja was employed as life support paramedic at the Groblersdal EMS Station. Ledwaba said the suspect is expected to appear before the Groblersdal Magistrate's Court soon.

The Provincial Commissioner of the Police in Limpopo, Lieutenant General Thembi Hadebe, expressed concerns about the ongoing incidents of gender based violence in the province, sending a warning to the communities to desist from such actions.

"These types of incidents indicate that there is something very wrong with our society and that we need to work together to prevent such heinous acts from happening," she said.

MEC for Health Department in Limpopo, Dr Phophi Ramathuba, has condemned the brutal murder.

"The loss of life of one person to domestic violence is but too many. We are extremely

saddened about the gruesome manner in which our employee, a life saver lost her life. The more sad part of the incident is that the victim is alleged to have died in the hands of someone she loved, her husband. It is very sad that we lost such a scarce skill to domestic violence," said Ramathuba.

The MEC has also, on behalf of the department, sent out condolences to the family and colleagues of the deceased. "The department has also arranged counselling for the family and colleagues of the victim," she said.

Multiple rapes accused gets hefty sentence

and overpowered and raped her. After the ordeal, the accused accompanied the victim home.

The court further heard that in December 2018, a 40 yearold woman from Siyabuswa B was on her way home when she met the accused who was known to her.

Spokesperson, said that as a result of his arrest, police got an opportunity to dig deep and discovered that he could be considered a serial rapist.

Mdhluli added that they discovered that the accused was in fact a parolee and it was revoked following proof that he violated conditions thereof. "The accused was positively linked to the said rape cases as well as the housebreaking case through evidence that was collected. He was charged with four counts of rape and he was further denied bail for the duration of the trial," further said Mdhluli. Kolobe was sentenced seven years imprisonment on a count one of rape, seven years on count two of rape, two years on count three of housebreaking with intent to rape, on count four rape, he was sentenced to 20 years impris-

onment and on count five of rape, he was also sentenced to 20 years imprisonment. On count 2,3 and 4 rape cases he was linked through DNA. The Regional Magistrate, Mawabo Malangeni indicated that people like the accused did not belong in the community and that they deserved to [ay for their sins. Malangeni also mentioned that justice needed to be served for the victims and the accused was also declared unfit to possess a firearm. His name would be entered into the national register of sexual offenders.

Winnie asked why the ANC failed to provide leadership in this situation affecting the lives of ordinary citizens. She said the ANC is also complicit in this situation.

"The ruling party is evidently a recipe for disaster and doesn't deserve to be running government, because it is no longer serving as an instrument for social change and development. The people of Ga-Nchabeleng can attest to this, as they are suffering to the extreme under the ANC gov-

Kolobe requested her to accompany him to his residence and when the victim resisted, he grabbed and forced her to his residential place where he kept her captive the whole night and then raped her until he freed her the next morning.

MALATANE - The police in Lebowakgomo outside Polokwane have opened an inquest after the body of a missing 21-month-old baby girl, Motheo Rashilo, was found in the bushes near Malatane Village last Wednesday.

According to police, the child's body was discovered after she was reported missing on Friday 28 October 2022.

Lieutenant Mamphaswa Seabi, Limpopo Provincial Police Spokesperson, said the mother allegedly left the child at her friend's place while she ran errands and when she returned, she was informed that the child had disappeared.

"Consequently, the mother reported the matter to Lebowakgomo Police Station. Police immediately started with investigations and search operations that ultimately led to the discovery of the body on Wednesday at about 16:00," added Seabi.

Seabi further said that it was not clear at that stage how the deceased got to the bushes but the unfolding investigations would ultimately reveal the cause of death.

He concluded that police appealed to community members to give them space to fully investigate the matter.

Anyone with information regarding the incident is urgently requested to contact the investigating officer, Detective Sergeant Michael Magadani at 072 029 7499, the crime stop number 08600 10111, the nearest police station or MySAPSApp. Helga Hlongwane, Democratic Alliance (DA) Councillor in Lepelle Nkumpi Local Municipality, said the area has been plagued by abductions and muti-related killings over recent years and that the safety of children required vigilance and action from society as a whole.

EFF march to demand better health services

Freedom Fighters (EFF) in Fetakgomo

Tubatse Local Municipality (FTLM) has recently marched to Burgersfort Clinic, aiming to deliver a memorandum of grievances to Health Department MEC in Limpopo Dr Phophi Ramathuba.

However, the MEC was not available to receive the EFF memorandum during the day, citing that she had other government commitments.

The march was ignited by a number of complaints in relation to poor service delivery rendered by the public health institution, including among others, a recent incident where a heavily pregnant woman delivered a baby at the Burgersfort Clinic gates.

March Coordinator, Edward Phasha, said they were marching to raise a voice about the public's right to health care service as a basic human right guaranteed by the South African Constitution, to all citizens and everyone who live in it.

"Section 27 of our constitution provides that everyone has the right to have access of health care service including reproductive health care service. No one to be refused emergency medical treatment. Although our constitution guaranteed this right, it is difficult for the people of Sekhukhune to exercise them because our clinics have a closing time while they have to open day and night for them to exercise their right to health care service," he said.

According to Phasha, on this basic right, EFF Sekhukhune Region demand the smooth run of Sekhukhune health care facilities, which will come as a relief to the people.

Phasha indicated that part

of the EFF demands included 24 hours clinics operations in Sekhukhune Region, all hospitals to have Human Resource (HR) Managers, Risk Assessment Managers, Financial Managers and Information and records managers with more kitchen staff and mortuary staff for the health facilities.

"We urge the health department senior officials that we are the beneficiaries of the government and that we deserve a healthy treatment and fair health care service from all public healthcare facilities. We are no longer slaves, this is a democratic country and we have been released from that bondage by the very same constitution," he said.

Phasha said the memorandum was later forwarded to Ramathuba's office and they have given the MEC 14 working days to respond to their grievances.

More measles cases confirmed in Limpopo

Limpopo Health MEC Dr Phophi Ramathuba has advised parents, guardians and caregivers to remain vigilant as more positive laboratory confirmed measles cases are registered in both Sekhukhune and Mopani District.

Since the beginning of September 2022, Limpopo Department of Health has been on the alert screening, testing and vaccinating children for measles to avoid the spread of the disease.

As of 01 November 2022, 4 new cases were detected in the Mopani District with 2 from Phalaborwa Municipality, 2 from Greater Giyani Municipality and 1 case from Sekhukhune District in the Fetakgomo Tubatse Municipality which bring the total number of the Measles cases to 23 to date.

Measles is a viral infection that's serious for small children but is easily preventable by a vaccine. It is a highly infectious and spreads rapidly from person to person and persons of any age who are not vaccinated can catch measles and develop a disease. The disease spreads through the air by respiratory droplets produced from coughing or sneezing.

"If you see any person presenting with fever accompanied by maculopapular rash plus anyone of the three cough, conjunctivitis, and running nose, we should immediately visit our nearest health care facilities while isolating them for medical care. We encourage parents to bring their children to the nearest clinic for measles vaccination catchup if they have missed the 6 months and 12 months measles program. Let's help prevent the spread of measles outbreak. Our district vaccination teams will be on the ground to make sure that no child is left unvaccinated. If we work together we can defeat this disease", said Ramathuba.

DA concern about Philadelphia Hospital ailing healthcare services



The DA in Limpopo is concerned about shortage of Ephedrine and Dopamine in Philadelphia Hospital in Dennilton.

The Democratic Alliance (DA) in Limpopo says it has on Wednesday 9 November, written to Health MEC, Phophi Ramathuba, for an urgent meeting on the constant serious challenges facing Philadelphia Hospital in Dennilton outside Groblersdal.

According to the party, the hospital currently does not have long-acting muscle relaxant, or anaesthetic drugs used in theatre.

"The hospital does not have Ephedrine and Dopamine which is used when blood pressure is low in the Intensive Care Unit (ICU). These are very important drugs which may result in the death of patients if not readily available for use," DA Limpopo Spokesperson for Health, Risham Maharaj.

Maharaj said the department and hospital management have also failed to repair or replace important equipment's such as the blood gas machine and the anaesthetic machine.

"The DA wrote to Ramathuba one month ago and raised challenges on the failure to maintain and repair the anaesthetic machine and the blood gas machine in the ICU and casualty ward, but there has been no effort to address this



issue," informed Maharaj. Maharaj indicated that DA was recently informed of the appointment of a new CEO and Senior Clinical Manager, however, this seems to have had no improvements in the hospital's longstanding challenges.

"It is clear that there is a need for urgent intervention at the hospital to address these pressing challenges before lives are needlessly lost. The DA is committed to ensuring that residents of Limpopo receive adequate healthcare services and we will continue to monitor the situation at Philadelphia Hospital," concluded Maharaj.

Limpopo Health MEC Spokesperson, Tilivhali Muavha slammed the DA claims, saying the hospital does not have any challenge of Ephedrine.

"We do have enough stock in different wards which is even reflecting on our systems for anyone to view," he said.

Muavha said Dopamine as well, is available enough to cover the hospital as they are also expecting another delivery from the supplier.

"Muscle relaxants are also available in the hospital and the operations are up and running," he said.

Apel police station under sourced



The EFF members says the Apel police station is under sourced.

APEL The Economic Freedom Fighters (EFF) in Limpopo said it has learnt with shock and disbelief that the Apel Police Station based at Ga-Nchabeleng village in Apel, is under resourced to an extent of not operating for 24 hours, regardless of the rampant crime plaguing the area.

The red beret said the safety of residents is at stake, given that the station operates like a Tuck Shop, let alone the lack of Police vans, manpower and police visibility.

A member of provincial legislature Winnie Mphahlele said police officers use corrugated mobile offices with little to no privacy for victims of crime such as GBV.

Winnie said her organisation is deeply concerned about the way the Police Station in question is being managed because when it opens at 6 AM and closes at 6 PM on a daily basis, it means that during the night residents cannot report cases such as rape, robbery, car theft, housebreaking etc.

The party lamented safer festive season operations campaign launched by minister of police in Thohoyandou last week calling it "toothless and directionless"

"It is an undisputable fact that policing in Sekhukhune is in crisis while SAPS and law enforcement agencies are not implementing comprehensive safety and crime prevention programmes. The cires the PR stunts made by Minister of Police Bheki Cele who launched a toothless and directionless so called safer festive season operations campaign in Thohoyandou last week. How can SAPS ensure residents' safety during festive season while Police officers knock off at 6pm, thus throwing the residents into the lions den daily," said Winnie.

"The campaign is unfounded and does not inspire hope nor confidence especially here in Limpopo where robberies, murders, rape and GBV incidents are rife with criminals having more ammunition and automatic weapons more than the Police who are supposed to prevent crime and protect the community," she said.

Winnie also said the EFF is dismayed by the lack of Police personnel and resources such as Police vans and satellite police stations in rural areas, this is a serious concern and a major contributor to the prevalence of crime.

"At this stage, we cannot shy away from the fact that the prevailing conditions on the ground suggest that Police officers are most likely to be overwhelmed and over powered by criminals," Winnie explained.

"The EFF calls on SAPS and the Limpopo Department of Transport and Community Safety to ensure that the Apel Police Station is operational for 24 hours, seven days per
