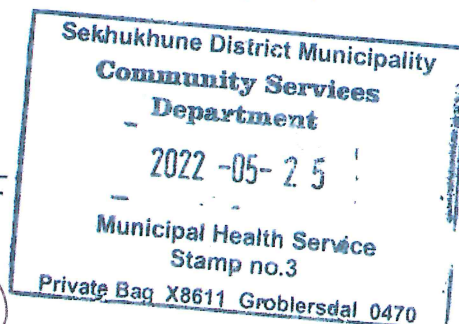

**RE: MINIMUM HEALTH REQUIREMENTS FOR REBURIAL OF MORTAL REMAINS  
AT MANOGENG**

1. Your application for reburial of mortal remains in respect of the skeletal remains at the above place is hereby approved.
2. The following minimum health requirements in terms of Government Notice R363 of 22 May 2013 s27 (1) (b) published under National Health Act 2003 (Act no. 61 of 2003) must be adhered to:
  - 2.1 Reburial must take place under the supervision of Environmental Health Practitioner to monitor the activities in compliance with the regulation.
  - 2.2 Reburial must be done by a competent funeral undertaker.
  - 2.3 Adequate supply of water, soap and disinfectant for cleansing purposes must be available at the grave for cleansing of persons handling Mortal remains.
  - 2.4 Mortal remains must be placed in a non-transparent and closely sealed container for reburial.
  - 2.5 The remains including pieces of coffin must be handled in a manner that no health nuisance or environmental hazard is caused.
  - 2.6 Health and safety of all workers must be maintained by use of approved protective equipment.
3. The gravesite must be treated with dignity and without violating other laws governing such sites.
4. Attached kindly find pro forma invoice to be paid prior commencement to your activities.
