**IMPOPO** The Limpopo Provincial government has welcomed the Public Protector South Africa's report on "Allegations of maladministration, procurement irregularities and nepotism in the awarding of tenders for the supply and delivery of Personal Protective Equipment (PPE) by the Limpopo Department of Health"

The Public Protector had taken own initiative on 17 August 2020 to investigate the matter following the reports in the Sunday Independent of 16 August 2020. The newspaper reports indicated that the tender was awarded irregularly, that it did not follow relevant procurement prescripts and legislations, that there was some favouritism and nepotism in its award and that politicians who are close to the ANC were favoured for the awarding of the tender.

"The Public Protector could not find evidence indicating that the Department did not follow paragraph 14.2.5 of the SCM policy or that the Department contravened National Instruction Note No.05 of 2020/2021: Emergency Procurement in response to the national disaster paragraph 3, which also regulates deviations from inviting bids in instances of emergency," the Public Protector said in their report issued on 29 April 2022.

According to Ndavhe Ramakuela, Provincial Government spokesperson, in addition, the Public Protector could not find any evidence indicating that the (Member of Executive Council) MEC responsible for Health and HOD (Dr Phophi Ramathuba) had any influence in the awarding of PPE tenders even though there is evidence that indicates that some of the service providers are related to politicians and senior government officials.

"The Public Protector could not find evidence to prove the alleged possible influence in the procurement processes of the awarding of PPE tenders or the relationship between the

Directors of the companies awarded tenders and officials of the department," revealed Ramakuela.

He said the Provincial Government is also pleased that the allegation "that other service providers suffered prejudice as a result of nepotism or favouritism in the awarding of the PPE tender, is unsubstantiated. "The Public Protector could not

find any evidence indicating undue influence, nepotism and or favouritism during the investigation in the awarding of PPE tenders to the said companies.

"The Premier will implement the remedial action against the implicated officials as directed by the Public Protector to remedy the maladministration and improper conduct referred to in the report. Moreover, disciplinary action has already been instituted against the officials implicated in the Special Investigative Unit (SIU) report on the same matter.'

# Lerule-Ramakhanya leads a multidisciplinary operation in **Tubatse**





#### BURGERSFORT

Fed up residents of Maapea Mpheti in Ward 17 protested to the Fetakgomo Tubatse Local Municipality (FTLM) demanding better services on Friday. The residents were in solidarity with the members of the EFF in Tubatse. The group handed their memorandum of demands to the management at the FTLM

The residents protested at the municipality on Friday

The residents indicated the municipality has done nothing to ensure acceleration of service delivery in their

village.

Residents claimed for the past years, they had been without electricity, water and some of them have no homes.

"We feel neglected by our own municipality, the deny us our rights to have water and electricity," said the residents In their memorandum, they indicated. "In 2019, we submitted a list of households to be electrified, they were 360 homes. None of the houses was electrified. The number has doubled and we have

power," said the protesters. According to the protesters, they were not considered in the FTLM's current Integrated Development Plan (IDP) buaget.

The residents also seemed concerned about the lack of water in their community. "Since the borehole was stripped, we don't have an alternative water supply. Not even a nearby river. We rely on buying water," they complained. The memorandum was received by MM Mabelane, Head of development and planning at the FTLM.

The Maapea Mpheti residents and EFF gave the FTLM seven days to respond to the memorandum of demands.

#### **STEELPOORT**

s part of the Department's mandate to keep the communities safe, the MEC for Transport and Community Safety in Limpopo, Mavhungu Lerule-Ramakhanya together with the SAPS Provincial Commissioner Lt. General Thembi Hadebe fringed by the Acting HoD Steve Matjena and other senior officials in law enforcement led a multi-disciplinary operation in Tubatse-Fetakgomo local Municipality.

The operation commenced with an oversight visit to the Burgersfort police station where a briefing on the status quo in the policing precinct and a walk-about around the police station transpired. Notions and recommendations were made regarding the conditions and design of the station facilities, with more focus on prudence when attending to GBV cases. The MEC acknowledged the service delivery improvement efforts at the station and stimulated personnel to always serve the community members with respect.

The second part of the day's planned activities was an Unannounced School Visit at Manoke High School, where searches for elicit substances, awareness against the use of drugs and anti-bullying were conducted.

MEC Lerule-Ramakhanya and her entourage proceeded to extension 10 in Burgersfort where a door to door campaign against Gender Based Violence ensued. Several households were visited, hawkers and bystanders warned against GBV and encouraged to stand together and Break The Silence against the scourge and criminality. Information material on GBV with safety tips were distributed throughout the location.

The MEC and the PC were hosted at the Tubatse Community Radio Station before proceeding to Steelpoort where a Roadblock operation was set up as an end statement to the day's program.

The Roadblock yielded the following successes, four illegal immigrants arrested, three suspects arrested for cable theft, one suspect arrested for illicit cigarettes, 26 traffic summons issued, 14 warrants of arrest executed.

Other success included 16 drink and drive screening done, 75 vehicles tested for road worthiness, 601 people searched and 573 vehicles searched.

Lerule-Ramakhanya thanked law enforcement officers on site for their participation in the operation and urged them to continue with diligent service even when she's not around.





Titus Tshungu, the EFF spokesperson in the province, said Gift was reportedly abducted from her home, in Kgaphamadi village by unknown suspects.

Tshungu said the mystery abductor was seen driving a white Honda Sedan.

"People in the surrounding

area only saw the car driving off and no one could see what Gift was wearing during the time of the abduction," said Tshungu.

"Information at our disposal is that police are hot on the heels for two men who are suspects in this case," he said.

Accordingly, the EFF appeals to the public for assistance in locating Gift.



The students, who are beneficiaries of the National Student Financial Aid Scheme (NSFAS), were urged to sleep at the university gate as they

were told the student funding scheme did not pay their

accommodation and their lease had lapsed.

The students were staying at the accommodation since the beginning of the year. They say they do not feel safe sleeping at the university gate and claim the university has refused to license the accommodation and renew their lease.

Students said they have been staying there for the past three months, not noticing that they will be evicted as soon as the accommodation lease lapsed.

Because it was very cold and raining, one student was reportedly sick while at the university gate and later admitted in hospital.

The evicted students claim they pleaded with the landlord to allow them to go inside but were refused entry and ended up sleeping outside in the cold and rainy weath-

Tshisikhawe said the university has taken the problem seriously and is working closely with campus management, the Students Representative Council (SRC) and student accommodation personnel to get an impeccable solution in the matter.

# **Clash between locals and foreigners** over farm jobs

#### **GROBLERSDAL**

Bolsheviks Party of South Africa Leader, Seun Mogotji, says they cannot tolerate discriminatory employment practices, which favours foreign nationals over South Africans in Groblersdal farms.

This is after some farms around Groblersdal replaced South African citizens with foreign nationals as seasonal and permanent workers.

The foreign nationals are alleged to be undocumented and in the country illegally working for lower wages than those demanded by South Africans.

Following the replacement, the expelled South Africans outraged and threatened to go and forcefully remove the foreign nationals from the farms to claim their jobs back.

A meeting was called at OR Tambo Stadium in Dennilton where the now unemployed farm workers voiced their unhappiness.

An interim committee that will be dealing with the issue of undocumented foreign nationals was formed by community leaders.

According to Mogotji, who is part of the interim committee, the structure will be working towards the establishment of the local Operation Dudula Movement, which will be dealing with issues of undocumented and documented foreign nationals in local farms.

"Following the fruitful meeting, we have written letters to the Police, Department of Home Affairs, Human Rights Commission, Department of Labour, Sekhukhune District Municipality and Elias Motsoaledi Local Municipality seeking their intervention to resolve this problem," he said.

Mogotji said the movement will ensure the elimination of possible xenophobic attacks as the appointment of undocumented foreign nationals could


fuel tension between foreigners and locals.

"This issue comes at a time when the country is battling with the issue of undocumented foreign nationals. This is the reason we want to engage relevant authorities as we won't take any responsibility on how the community might act when they visit the affected farms," he said.

However, Mogotji said they will not fold arms and watch local people suffer without jobs while foreign nationals work for cheap labour in local farms.

"We want to do this in a proper way and use Dudula to remove those who do not have valid documentation to can work in those farms," he said.

Mogotji said the interim structure has given relevant authorities 30 days to deal with the issue of undocumented foreign nationals in the farms around Sekhukhune District Municipality.

# office branches will no longer pay

The South Africa Post Office (SAPO) has announced it will no longer pay the R350 social relief of distress (SRD) grant through its branches across the country.

The State Owned Entity (SOE) said the move will help alleviate long queues at its branches, with many recipients of the grant having several options to collect their money

"The new round of application for the R350 SRD grant has opened. The application app includes an option where beneficiaries can receive their grant from any Pick n Pay, Boxer, Shoprite, Checkers or USave merchants," said Johan Kruger, SAPO national spokesperson.

He said the entity strongly advises beneficiaries to include this option as Post Office branches will

no longer pay out SRD grants.
"If you have already reapplied for your SRD grant, you can still select the option to collect your grant from any Pick n Pay, Boxer,

Shoprite, Checkers or USave. Log on to srd.sassa.gov.za and respond to the security SMS you receive on your phone. You can then include merchants in your application and submit the updated application, said Kruger.

He added that the beneficiaries must have their own cell number to withdraw their grant at supermarket and advised those without their own number to purchase SIM card and use that number to apply for the grant.

Beneficiaries will be assisted to reset card pins at the cash points. The card can then be used at merchants at ATMs," explained SAPO spokesperson.

He assured beneficiaries who receive old age, disability or child grant at Post Office branches that they will still collect the money there.

The change only affects those who are granted and approved to get SRD grand at the Post Office.

he Democratic Alliance (DA) in Limpopo, says it is worried about the increasing number of awaiting trial suspects who escaped from the custody of the police in the province.

custody are putting ordinary citizens at great risk.

The party said its concern emanates from a shocking recorded number of 430 awaiting trial suspects who escaped from police custody in the past five years.

The shocking stats of the escapees were released by National Commissioner of the Police General Fani Masemola, indicating that during the past five years, Limpopo recorded 230 escapes from police holding cells, the highest nationally. In addition, 24 suspects escaped from police vehicles and a further 176 escaped from physical police detention.

DA Provincial Spokesperson on Transport and Community Safety, Katlego Suzan Phala, said they are worried that the majority of the escaped suspects were not arrested.

""From the 430 escapees, only 321 were re-arrested, leaving 109 criminals to endanger the safety of our communities. It is unacceptable that over 5 years, only 40 police officers in Limpopo were charged for negligence in the 430 incidents. In the Free State there were 179 escapes over the same period and 147 officers were charged with negligence," said Phala.

She said the party has submitted a written questionnaire to the National Council of Provinces (NCOP) and they

were simultaneously submitted to the Limpopo MEC for Transport & Community Safety, Mavhungu Lerule-Ramakhanya.

DA Limpopo Provincial Spokesperson on Transport and Community Safety, Katle-

go Suzan Phala, says the party is worried about suspects who escape from police

'We are still awaiting for a response from Lerule-Ramakhanya regarding the submitted questionnaire," Phala said.

According to Phala, only 40 police officers in Limpopo were charged for negligence in the 430 incidents happened in the past five years.

"In the Free State there were 179 escapees over the same period and 147 officers were charged with negligence. What is happening in our province is unacceptable," she said.

Phala said the DA is concerned that a lack of adequate detention facilities and minimal resources and the lack of effective training, increases opportunities for criminals to escape. "Furthermore, the inefficacy of SAPS to secure prisoners and prisoners awaiting trail during their incarceration in police cells and the transportation to and from court, is putting ordinary citizens at great risk," she said.

She indicated that they are concerned about MEC Mavhungu Lerule-Ramakhanya's failure to provide answers to their questions, as her mandate to provide is indicative of lack of transparency in her department.

"The DA will continue to accentuate the challenges within the SAPS that prevent our men and women in blue to ensure their own safety and the safety of our communities," she said.



AFELKOP - Following a fatal hit and run incident that claimed life of a community member on the R579 Road in Tafelkop, the Mayor of Elias Motsoaledi Local Municipality, Cllr David Tladi, intervened to see that a speed hump is urgently erected on the killer road.

The speed hump was erected by the South African National Roads Agency Limited (SANRAL) last week Friday.

According to residents, more than ten community members have since died on the dangerous road in separate string of hit and run incidents.

The latest fatal incident occurred in the evening on Sunday 24 April wherein, a 30-year-old man named Sepadi Mankwe Moela, was hit by a speeding Toyota Quantum that failed to stop after the incident.

According to eyewitnesses, apparently the victim was also ran over by a speeding Toyota Avanza and died on the scene. Eyewitnesses alleges that the Avanza driver had also drove off after running over the victim who succumbed to serious injuries.

Last week Monday, angry residents of Mgababa Section in the village, mobilized and attempted to erect their own speed hump on the deadly

The crowd also threatened to disrupt the traffic until their concerns reach relevant people in government.

Following the threats, Tladi rushed to the scene and committed to meet relevant authorities, whereby, a speed hump was erected by SAN-RAL last week Friday.

A community member, who did not want to be named, said they were worried that the road had already claimed lives of more than ten villagers, with the government doing nothing about the situation.

"We are happy now that our concerns were heard and the speed hump was erected. This will save lives because motorists were always speeding, especially at night. We have been pleading with government to intervene and now we are glad with the mayor's immediate action," he said.

Limpopo Provincial Police Spokesperson, Brigadier Motlafela Mojapelo, said a case of culpable homicide is under investigation at Motetema Police Station.

"The police were called to a scene of an accident where a pedestrian was hit by an unknown vehicle that failed to stop after the incident. The victim was identified as Sepadi Mankwe Moela and was certified dead at the scene," he said.

Mojapelo said no arrests were made and the suspect(s) is not known at the stage but police investigations are underway.

"Anyone with information is requested to contact the police toll free line on 08600 10111 or the nearest police station," he said.

#### HAWKS secure preservation order into allegations of drug dealing investigation worth R4 million

**SEKHUKHUNE-** The Directorate for Priority Crime Investigations' (HAWKS) Asset Forfeiture team together with the National Prosecuting Authority (NPA)have secured a preservation order into the allegations of drug dealing worth R4 million.

Captain Matimba Maluleke, HAWKS Limpopo Spokesperson, said the order was obtained on 22 April 2022, from the Polokwane High Court.

Maluleke said that on 16 June 2020, the police in Marble Hall discovered a huge clandestine drug laboratory on Pieon Game Farm within the Marble Hall area.

"Police arrested two suspects and seized drugs worth over R10 million as well as firearms. The HAWKS' serious

organized crime investigation members were entrusted with the investigation of the case. While the members were conducting further investigation, vehicles that included a Mercedes Benz truck, Great Wall Motors truck, Diamond trailer, Great Vinno trailer, Toyota Hilux and Perkins generator were recovered from the farm and seized," informed Maluleke.

He said that the court in terms of Section 38(3) read with Section 41 of the Prevention of organized Crime Act, no 121 of 198 gave the HAWKS' Assets Forfeiture an authority to preserve the seized assests including Pieon Game Farm situated at Toitskraal outside Marble Hall until the outcome of the forfeiture proceedings was instituted





he International Federation of Association Football (FIFA) has officially lifted a ban of registering new players for Marumo Gallants. DSTv premiership club was banned from registering new players following a dispute with former Kaizer Chiefs striker Gustavo Paez.

This comes after Marumo had failed to compensate the Venezuelan forward for prematurely terminating his contract in 2020 after he had signed with Tshakhuma Tsha Madzivhandila (TTM), who later sold their status to Marumo.

Bahlabane ba Ntwa were then handed a 3-year transfer ban on registering new players inherited from former TTM.

"Following the failure to compensate Paez, Marumo FC were handed a three-year transfer ban on registering new players," read the statement sent out by the club.

"Marumo Gallants FC appealed the ban, which was inherited from the former TTM FC. After lengthy discussions, Marumo Gallants and Paez reached a settlement agreement, resulting in the lifting of the ban, which was officially confirmed in a letter to the club issued by FIFA this week,"

Commenting on the issue, Marumo Gallants chairman Abram Sello said: "we are relieved that the matter has been amicably resolved and that we will be able to plan for the next season,"

The Gallants are current defending champions of the Nedbank Cup 2021/22. Having made it through to the final round of this year's competition, the Gallants will take on recently crowned DSTv premiership champions Mamelodi Sundowns on May 28.
