In terms of Section 36 (3) of the National Heritage Resources Act, 1999 (Act No. 25 of 1999) no person may, without a permit issued by the relevant heritage resources authority:

- (a) destroy, damage, alter, exhume or remove from its original position or otherwise disturb the grave of a victim of conflict, or any burial ground or part thereof which contains such graves;
- (b) destroy, damage, alter, exhume or remove from its original position or otherwise disturb any grave or burial ground older than 60 years which is situated outside a formal cemetery administered by a local authority; or
- (c) bring onto or use at a burial ground or grave referred to in paragraph (a) or (b) any excavation equipment, or any equipment which assists in the detection or recovery of metals.

Other application forms are available for archaeological and palaeontological material and sites (302), for shipwrecks (303), for the export or sale of heritage objects including archaeological and palaeontological material, material from shipwrecks and meteorites (304), for the built environment and landscape (307) or the registration of private collections (402).

Three suspected Burial sites were accidentally exposed during construction work along the Ermelo Majuba Railway servitude near Amersfoort in PixleyKaSeme Local Municipality. Work was suspended the suspected burial sitesand the sites were barricaded in accordance with the relevant heritage legislation and Management plan for the railway development.

## 10. Brief description: Figure 1 and 2.View of burial site EMRS 1, 2 and 3.

Figure 1, 2and 3-View of burial site along Ermelo Majuba Railway servitude and David Twala an informant from the project area.









Three separate stone cairns were discovered within a railway line development area during construction work along the Ermelo to Majuba railway servitude near Amersfoort in PixleyKaSeme Local Municipality in Mpumalanga Province. Given the shape that potentially resemble traiditional graves, precautionary measures were taken to treat the stone cairns as potential graves. Construction work was suspended following the discovery and the suspected graves were condoned off. Eskommanagement commissioned Nzumbululo Heritage Solutions (Heritage specialists) in collaboration with Mafu Funeral Home to verify the suspected graves and to proceed to apply for reburial permits in order to relocate the graves from the direct path of the railway servitude. This accidental discovery of suspected human burials prompted the necessity of applying section 36(3) of the National Heritage Resources Act 25 of 1999.

However, in 2009 Nzumbululo Heritage Solutions was commissioned by Eskom to relocate some graves identified along the same railway servitude area. SAHRA BGG Unit issued a permit for 13 graves along the Ermelo to Majuba railway servitude(See attached report and burial permit

no.BG/09/03/002/87). The burial permit was valid up to 2010. However the Ermelo to Majuba railway development was suspended and only resumed in 2013. As such, no further monitoring for accidential or chance finds were conducted in the project area until now.

Following the recent accidental discovery of previously un-recorded potential graves, Nzumbululo specialists inspected the suspected sites and associated stone cairns but could not conclusively define the stone piles as graves. The suspected graves are located near where some burials were removed in 2009. The forms of the suspected burials resemble that of historical and contemporary burials in the project area. No grave goods were recorded on the suspected graves. A disturbed stone structure was recorded outside the servitude near Grave number EMRS 3. Grave number EMRS 1 and 2 are also located near remains of stone structures which are located outside the railway servitude. Although we cannot physical ascertain the status of the suspected graves we may not allow the contractor to destroy the stone cairns without conclusively ruling them out as potential graves. We need to conduct test excavation to determine whether they are graves or not.

Nzumbululo team consulted some families who relocated their graves from the project area in 2009. They confirmed that they were not aware of any other graves on the railway servitude. The team went on to consult key informants to find out if any family claimed the graves during the commencement of construction work along the servitude. David Twala of Amersfoort who assisted during the tracking of affected families in 2009 inquired from elderly citizen including Mr Nkosi. They both indicated that they are not aware of the existence of any known graves within the railway servitude. They indicated that if the suspected graves are real graves then they possibly belong to migrant farm workers whose families left the project area long ago.

The costs of this exercise are included in the professional services being provided by Mafu's Funeral Home and Nzumbululo Heritage Solutions (see attached contract). This includes cost of reburial of final reburial of the human remains. Nzumbululo in collaboration with Mafu's Funeral Home has obtained permission for the graves to be re-interred in the local cemetery at Zamokhuhle. Mafu's Funeral Home is the approved undertaker service provider and will be managed by Nzumbululo Heritage Solutions to conduct the reburial work.

This is an urgent Rescue Permit application given the observation that thesuspected burials are located with an active earthwork development area and that they cannot be preserved in situ. Site management and construction workers are concerned that should subsurface work continue in the area, they may exposed human remain that may derail progress on the railway servitude. As such the Eskom Management urgently need the suspected burials to be tested, confirmed and if human remains are discovered relocated without any incidents. With the necessary arrangements having been agreed upon with the developer, and that there is no custodian claiming the graves, we request that the SAHRA BG&G Unit process this urgent application to enable the immediate verification and if need relocation of the suspected graves. Should there be any other information that the Agency may require in this regard, Nzumbululo Heritage Solutions will be obliged to make the necessary submissions





Figure 6 - Locality Map

Nzumbululo Heritage Solutions assisted by Mafu Funerals will conduct the test excavation/ exhumation and reburial. A qualified archaeologist from Nzumbululo Heritage Solutions will manage and supervise the whole exhumation process. He will also undertake and complete the reporting process thereof.

18. Please give details of consultation with communities and individuals who by tradition have an interest inthe grave(s), and of the agreement reached with such communities and individuals (as required by Act 36 and the relevant Regulations Chps IX and XI)(provide documentation and details):

Consultations were conducted at Amersfoort and surrounding areas. Families and informants who relocated their graves in 2009 were tracked and were consulted. The families denied knowledge of existence of any known graves along the railway servitude. As such the suspected graves will be treated as unknown burials. Mr David Twala and Nkosi provided important information about the affected area. David Twala assisted by announcing the discovery to Amersfoort residence. Eskom management was also consulted to grant permission for the relocation of the exposed burial (See attached Eskom task order). The process was deemed sufficient for the urgent relocation and reburial of the three adversely affected graves - a mitigation measure to rescue the grave from further disturbance from railway line developments. 
