Executive Summary

Camden Green Energy RF (Pty) Ltd is proposing the development of the proposed Camden I Wind Energy Facility (up to 210MW), which is part of the larger Camden Renewable Energy Cluster project. This facility will require a Grid Connection and this will be on portions of the following farms: Klipbank 295, Adrianople 296, Welgelegen 322 and Klipbank 295. There are four alternative routes.

WSP has been appointed as the independent Environmental Assessment Practitioner (EAP) to undertake the requisite Environmental Impact Assessment (EIA) process for the Project. Beyond Heritage was appointed to assess the potential impact to heritage resources by the Project and Marion Bamford was sub-contracted to do the palaeontological impact assessment. This report is for the site visit assessment.

To comply with the regulations of the South African Heritage Resources Agency (SAHRA) in terms of Section 38(8) of the National Heritage Resources Act, 1999 (Act No. 25 of 1999) (NHRA), a site visit (Phase 2) Palaeontological Impact Assessment (PIA) was completed for the proposed development.

The proposed turbine sites predominantly lie on the potentially fossiliferous Vryheid Formation (Ecca Group, Karoo Supergroup) that could preserve fossil plants of the Vryheid Formation. A short section of the route lies on the non-fossiliferous Jurassic dolerite. The site visit and walk through confirmed that there were NO Fossils present on the land surface. It is not known what lies below the ground surface, therefore, a Fossil Chance Find Protocol should be added to the EMPr. Based on this information it is recommended that no further palaeontological impact assessment is required unless fossils are found by the contractor, developer, environmental officer or other designated responsible person once excavations for foundations and infrastructure have commenced. Since the impact will be low, as far as the palaeontology is concerned, the project should be authorised.

All routes have sections on the Vryheid Formation but Alternative 2 (yellow line) is mostly on non-fossiliferous dolerite. This would be the preferred alternative as far as the palaeontology is concerned. There are no No-Go areas.

1. Background




Figure 1: Aerial Map of the proposed Grid Connection for the Camden I WEF with the four alternatives as indicated in the legend.

The proposed Camden I Wind Energy Facility (WEF) is part of the larger Camden Renewable Energy Cluster project to the west of Camden, Mpumalanga Province. A grid connection is required for the Camden I WEF and there are four alternative routes. These are planned for Portions of the Farms Klipbank 295, Adrianople 296, Welgelegen 322 and Klipbank 295 (Figures 1-3).

The proposed Camden Renewable Energy Cluster of projects is being developed in the context of the Department of Mineral Resources and Energy's (DMRE) Integrated Resource Plan, and the Renewable Energy Independent Power Producer Procurement Programme (REIPPP), with further potential for private off-take by nearby mining and industrial operations.

The Cluster comprises eight (8) distinct projects, namely:

- i. Camden I Wind Energy Facility (up to 210MW).
- ii. Camden I Wind Grid Connection (up to 132kV).
- iii. Camden up to 400kV Grid Connection and Collector substation.
- iv. Camden I Solar 100MW.
- v. Camden I Solar up to 132kV Grid Connection.
- vi. Camden Green Hydrogen and Ammonia Facility, including grid connection infrastructure.
- vii. Camden II Wind Energy Facility (up to 210MW).
- viii. Camden II Wind Energy Facility up to 132kV Grid Connection.

This report is the palaeontological impact for the Grid Connection for the Camden I Wind Energy Facility and infrastructure.

Enertrag South Africa is a subsidiary of the German-based Enertrag AG, a hydrogen and renewable energy developer founded in 1992. Enertrag South Africa (hereafter "ENERTRAG SA") was established in 2017, with the intention to investigate and develop renewable energy projects in South Africa. The transition from coal-based energy supply to renewables in the Country is inevitable, as coal resources are becoming depleted, coal-based power stations reach the end of their economic life and considering international obligations and commitments to reduced emissions. This Complex serves as the first step to this transition.

The Camden I Wind Energy Facility, to be known as the Camden I Wind Energy Facility (RF) Propriety Limited, in the Msukaligwa Local Municipality of the Gert Sibande District Municipality, will be on the land parcels as listed above.

It is proposed that Camden I will connect to the nearby Camden Collector substation (which in turn will connect to the Camden Power Station), through an up to 132kV powerline (either single or double circuit) between the grid connection substation portion (immediately adjacent the Camden I on-site IPP substation portion) and that of the Camden Collector substation. The powerline will be approximately 14km in length, depending on the authorized location of the collector substation. The onsite grid connection substation will consist of high voltage substation yard to allow for multiple (up to) 132kV feeder bays and transformers, control building, telecommunication infrastructure, access roads, etc. The area for the onsite substation will be up to 1.5ha. The up to 132kV powerline and substation will have a 250m corridor. This application includes the necessary up to 132kV voltage electrical components required for connection at the Collector Substation.

The affected farms for the Grid Connection are:

- Portions 0 and 3 of Farm Klipbank 295
- Portions 0, 1 and 3 of Farm Adrianople 296
- Portions 1 and 2 of Farm Welgelegen 322
- Portion 3 of Farm Klipbank 295

There are four alternatives for the grid connection route as illustrated in Figures 1-2.




Figure 2: Regional Map of the proposed four alternative routes proposed for the Grid Connection for the Camden I Wind Energy Facility.




Figure 3: Locality map for the Grid Connection for the Camden I WEF with four alternative routes.

A Palaeontological Impact Assessment was requested for the proposed Grid connection for the Camden I Wind Energy Facility. To comply with the regulations of the South African Heritage Resources Agency (SAHRA) in terms of Section 38(8) of the National Heritage Resources Act, 1999 (Act No. 25 of 1999) (NHRA), a site visit and walkthrough (Phase 2) Palaeontological Impact Assessment (PIA) was completed for the proposed development and is reported herein.

2. Methods and Terms of Reference

The Terms of Reference (ToR) for this study were to undertake a PIA and provide feasible management measures to comply with the requirements of SAHRA.

The methods employed to address the ToR included:

- 1. Consultation of geological maps, literature, palaeontological databases, published and unpublished records to determine the likelihood of fossils occurring in the affected areas. Sources included records housed at the Evolutionary Studies Institute at the University of the Witwatersrand and SAHRA databases;
- 2. Where necessary, site visits by a qualified palaeontologist to locate any fossils and assess their importance, as is the case here;
- 3. Where appropriate, collection of unique or rare fossils with the necessary permits for storage and curation at an appropriate facility (*not applicable to this assessment*); and
- 4. Determination of fossils' representivity or scientific importance to decide if the fossils can be destroyed or a representative sample collected (*not applicable to this assessment*).

3. Geology and Palaeontology

i. Project location and geological context




Figure 4: Geological map of the area around the Camden Renewable Energy Cluster with the Camden I WEF area shown within the oval outline. Abbreviations of the rock types are explained in Table 2. Map enlarged from the Geological Survey 1: 250 000 map 2630 Mbabane.

The site lies in the northern part of the Karoo basin where the older Karoo Supergroup strata are exposed. Along the rivers and streams much younger reworked sands and

alluvium overly the older strata. Extrusive dolerite of Jurassic age is abundant (Figure 4).

The Karoo Supergroup rocks cover a very large proportion of South Africa and extend from the northeast (east of Pretoria) to the southwest and across to almost the KwaZulu Natal south coast. It is bounded along the southern margin by the Cape Fold Belt and along the northern margin by the much older Transvaal Supergroup rocks. Representing some 120 million years (300 – 183Ma), the Karoo Supergroup rocks have preserved a diversity of fossil plants, insects, vertebrates and invertebrates.

During the Carboniferous Period South Africa was part of the huge continental landmass known as Gondwanaland and it was positioned over the South Pole. As a result, there were several ice sheets that formed and melted, and covered most of South Africa. Gradual melting of the ice as the continental mass moved northwards and the earth warmed, formed fine-grained sediments in the large inland sea. These are the oldest rocks in the system and are exposed around the outer part of the ancient Karoo Basin, and are known as the Dwyka Group (Johnson et al., 2006).

Overlying the Dwyka Group rocks are rocks of the Ecca Group that are Early Permian in age. There are eleven formations recognised in this group but they do not all extend throughout the Karoo Basin. In the Free State, Mpumalanga and KwaZulu Natal, from the base upwards are the Pietermaritzburg Formation, **Vryheid Formation** and the Volksrust Formation. All of these sediments have varying proportions of sandstones, mudstones, shales and siltstones and represent shallow to deep water settings, deltas, rivers, streams and overbank depositional environments.

Overlying the Ecca Group are the rocks of the Beaufort Group that has been divided into the lower Adelaide Subgroup for the Upper Permian strata, and the Tarkastad Subgroup for the Early to Middle Triassic strata. As with the older Karoo sediments, the formations vary across the Karoo Basin.

Large exposures of Jurassic dolerite dykes occur throughout the area. These intruded through the Karoo sediments around 183 million years ago at about the same time as the Drakensberg basaltic eruption.

Along the rivers and streams much younger transported sediments have been deposited. They were sourced from older weathered strata upstream (Partridge et al., 2006).

ii. Palaeontological context




Figure 5: SAHRIS palaeosensitivity map for the site for the proposed grid connection for the Camden I WEF within the yellow oval. Background colours indicate the following degrees of sensitivity: red = very highly sensitive; orange/yellow = high; green = moderate; blue = low; grey = insignificant/zero.

The palaeontological sensitivity of the area under consideration is presented in Figure 5. The site for development is in the Vryheid Formation (red; very highly sensitive) and the non-fossiliferous Jurassic dolerite (grey). The latter is an intrusive igneous rock and do does not preserve fossils, in fact, dykes can destroy any fossils that were in the rocks through which they have intruded.

The Vryheid Formation is potentially very rich in fossils of the *Glossopteris* flora. This flora includes *Glossopteris* leaves, seeds, roots, stems and reproductive structures, as well as other plants such as lycopods, sphenophytes, ferns, cordaitaleans and early gymnosperms (Plumstead, 1969; Anderson an Anderson, 1985; Bamford, 2004). Coal seams were formed from peats comprising these plants that were altered by heat and pressure to make coal. The coal itself, however, does not preserve any recognisable plant structure, but the shales associated with the seams can preserve recognisable impressions of the ancient plants (Plumstead, 1969).

iii. Site visit observations

A site visit and walk down along the proposed routes for the Camden I WEF facility in April showed that there were no fossils visible on the surface. The whole area has been cultivated for decades and the land is fairly flat with no rocky or shale outcrops and no fossils (Figure 6). The south-eastern route (yellow lines in maps) is more along dolerite than on the Vryheid Formation so it would have less impact on the fossil heritage.

No fossils were seen on the Vryheid Formation as the soils are deep and well-formed.

4. Impact assessment

The assessment of impacts and mitigation evaluates the likely extent and significance of the potential impacts on identified receptors and resources against defined assessment criteria, to develop and describe measures that will be taken to avoid, minimise or compensate for any adverse environmental impacts, to enhance positive impacts, and to report the significance of residual impacts that occur following mitigation. The key objectives of the risk assessment methodology are to identify any additional potential environmental issues and associated impacts likely to arise from the proposed project, and to propose a significance ranking. Issues / aspects will be reviewed and ranked against a series of significance criteria to identify and record interactions between activities and aspects, and resources and receptors to provide a detailed

discussion of impacts. The assessment considers direct¹, indirect², secondary³ as well as cumulative⁴ impacts.

A standard risk assessment methodology is used for the ranking of the identified environmental impacts pre-and post-mitigation (i.e. residual impact). The significance of environmental aspects is determined and ranked by considering the criteria⁵ presented in **Table**.

Impact Mitigation

If fossils occur in the footprint of any section of the project, the route for the grid connection (overhead powerline pole foundations/below ground piping), the hydrogen and ammonia facilities, access roads or infrastructure, they can be removed (details in Section 8, Fossil Chance Find Protocol), and the project can continue. If no fossils are found then no mitigation is required.

Once fossils have been removed there will be not further impact on the palaeontological heritage. Therefore the impact is only applicable to the construction phase. The operation and de-commissioning phases will NOT impact the palaeontology.

If fossils are recovered, removed and placed in a recognised institution such as a museum or university palaeontology collection this will be a positive impact because the fossils will be available for research. Otherwise they would have remained unknown to science.

5. Assumptions and uncertainties

Based on the geology of the area and the palaeontological record as we know it, it can be assumed that the formation and layout of the dolomites, sandstones, shales and sands are typical for the country and do contain fossil plant, insect, invertebrate and vertebrate material. The site visit and walk through confirmed that there are no fossils present on the land surface. It is not known if there are any fossils below the land surface. The sands of the Quaternary period and the Jurassic dolerite would not preserve fossils.

6. Recommendation

Based on the fossil record but confirmed by the site visit and walk through, there are NO FOSSILS of the *Glossopteris* flora even though fossils have been recorded from rocks of a similar age and type in South Africa. It is extremely unlikely that any fossils would be preserved in the overlying soils and sands of the Quaternary. There is a very small chance that fossils may occur below the ground surface in the shales of the Vryheid Formation (Ecca Group, Karoo Supergroup) so a Fossil Chance Find Protocol should be added to the EMPr. If fossils are found by the environmental officer, or other responsible person once excavations and drilling for foundations and amenities have commenced, then they should be rescued and a palaeontologist called to assess and collect a representative sample. All routes are acceptable as far as the palaeontology is concerned, but Alternative 2 (yellow) has a shorter distance on the Vryheid Formation so would be preferred.

8. Chance Find Protocol

Monitoring Programme for Palaeontology – to commence once the excavations / drilling activities begin.

- 1. The following procedure is only required if fossils are seen on the surface and when drilling/excavations commence.
- 2. When excavations begin the rocks and must be given a cursory inspection by the environmental officer or designated person. Any fossiliferous material (trace fossils, fossils of plants, insects, bone or coalified material) should be put aside in a suitably protected place. This way the project activities will not be interrupted.

- 3. Photographs of similar fossils must be provided to the developer to assist in recognizing the fossil plants, vertebrates, invertebrates or trace fossils in the shales and mudstones (for example see Figure 6). This information will be built into the EMP's training and awareness plan and procedures.
- 4. Photographs of the putative fossils can be sent to the palaeontologist for a preliminary assessment.
- 5. If there is any possible fossil material found by the developer/environmental officer then the qualified palaeontologist sub-contracted for this project, should visit the site to inspect the selected material and check the dumps where feasible.
- 6. Fossil plants or vertebrates that are considered to be of good quality or scientific interest by the palaeontologist must be removed, catalogued and housed in a suitable institution where they can be made available for further study. Before the fossils are removed from the site a SAHRA permit must be obtained. Annual reports must be submitted to SAHRA as required by the relevant permits.
- 7. If no good fossil material is recovered then no site inspections by the palaeontologist will be necessary. A final report by the palaeontologist must be sent to SAHRA once the project has been completed and only if there are fossils.
- 8. If no fossils are found and the excavations have finished then no further monitoring is required.
