SUMMARY

A survey of cultural resources for Secunda Collieries Block 5 and Syferfontein mining area, Highveld Ridge District, Mpumalanga.

The aim of the survey was to locate, identify, evaluate and document the sites, objects and structures of cultural importance found within the boundaries of the areas that is to be developed.

The following recommendations are put forward in section 8 of this report:

- The relocation of all the graves, their contents and headstones, if they are to be impacted upon by the proposed development.
- The archaeological investigation and documentation of the different Late Iron Age sites, especially those that are located in the areas where the shafts are to be made.
- The documentation of the various farmsteads, if they are to be impacted upon by the development.
- The developers should be notified that archaeological sites might be exposed during the construction work. If anything is noticed, it should be reported immediately to a museum, preferably one at which an archaeologist is available, so that an investigation and evaluation of the finds can be made.

A SURVEY OF CULTURAL RESOURCES FOR SECUNDA COLLIERIES BLOCK 5 AND SYFERFONTEIN MINING AREAS, HIGHVELD RIDGE DISTRICT, MPUMALANGA

1. AIMS OF THE SURVEY

The National Cultural History Museum was requested by **Walmsley Environmental Consultants** to survey a number of farms in the Highveld Ridge district. Sasol coal is planning to extent their mining operations in the area. The aim of the survey was to locate, identify, evaluate and document the sites, objects and structures of cultural importance found within the boundaries of the areas that is to be developed.

2. TERMS OF REFERENCE

The **Terms of Reference** for the study were to:

- 2.1 Identify all objects, sites, occurrences and structures of an archaeological or historical nature (cultural resources) located in the area of the proposed development.
- 2.2 Assess the significance of the cultural resources in terms of their historical, social, religious, aesthetic and scientific value.
- 2.3 Describe the possible impact of the proposed development on these cultural remains, according to a standard set of conventions.
- 2.4 Propose suitable mitigation measures to minimize possible negative impacts on the cultural resources. This can include recommendations for the sustainable development and use of the identified cultural resources.
- 2.5 Develop procedures to be implemented if previously unidentified cultural resources are uncovered during the construction phase.

3. **DEFINITIONS**

The following aspects have a direct bearing on the survey and the resulting report:

3.1 **Cultural resource** is a broad, generic term covering any physical, natural and spiritual properties and features adapted, used and created by humans in the past and present. They can be, but are not necessarily identified with defined locations.

- 3.2 The **significance** of the sites and artifacts is determined by means of their historical, social, aesthetic, technological and scientific value in relation to their uniqueness, condition of preservation and research potential. It must be kept in mind that the various aspects are not mutually exclusive, and that the evaluation of a site is done with reference to any number of these.
- 3.3 Significance is site-specific and relates to the content and context of the site. Sites regarded as having low significance have already been recorded in full and require no further mitigation. Sites with medium to high significance require further mitigation.
- 3.4 The latitude and longitude of an archaeological site are to be treated as sensitive information by the developer, and should not be disclosed to members of the public.
- 3.5 All recommendations are made with full cognisance of the relevant legislation, in this case the **National Monuments Act (No 28 of 1969, as amended)**.

4. METHODOLOGY

4.1 **Preliminary investigation**

4.1.1 Survey of the literature

A survey of the relevant literature was conducted with the aim of reviewing the previous research done and determining the potential of the area. In this regard, various anthropological, archaeological and historical sources were consulted - see list of references below.

4.1.2 Data sources

The Archaeological Data Recording Centre (ADRC), housed at the National Cultural History Museum, Pretoria, was consulted.

4.1.3 Other sources

The topocadastral and other maps were also studied - see list of references below.

4.2 Field survey

The field survey was done according to generally accepted archaeological practices, and was aimed at locating all possible sites, objects and structures. The area was divided into blocks, making use of natural and human-made topographical elements. These blocks were then surveyed in detail by walking and driving across it. In each block, areas with a

potential for human use were investigated. Special attention was given to outcrops, cliffs were inspected for rock shelters, while stream beds and unnatural topographical occurrences such as trenches, holes and clusters of trees were investigated. In the case of the location of graves, information was in many cases also supplied by landowners.

4.3 **Documentation**

All sites, objects and structures identified were documented according to the general minimum standards accepted by the archaeological profession. Coordinates of individual localities were determined by means of the **Global Positioning System** (GPS)¹ and plotted on a map. This information was added to the description in order to facilitate the identification of each locality.

5. DESCRIPTION OF THE AREA

The area under investigation is situated north of the town of Trichardt, in the Highveld Ridge district of Mupmalanga. The topography of the area is mainly gently rolling highveld, with the most important geographical features the various streams crossing the area, such as the Trichhardspruit and Debeerspruit. The soil is mostly turf, which was not deemed suitable for settlement on by Iron Age people. Settlement usually took place on the various dolorite outcrops, which is also still largely the case. The current land use is mainly livestock and maize farming and very little of the original vegetation remains. The latter is classified as Themeda Veld or Turf Highveld, with no other species playing an important part (Acocks 1975:92).

6. DISCUSSION

Intensive settlement of the area under consideration took place only during the last few hundred years. Stone Age occupation seems to be totally lacking in the area. Only a few Middle Stone Age tools were identified in the various stream beds, but are viewed not to be in primary context as they could have been washed downstream.

No Early Iron Age sites were identified in the area, and it seems as if Early Iron Age people did not settled here. This is confirmed by Maggs (1984:199), who indicates that the preference these people had for selecting sites was savanna areas below 1000m.

¹ According to the manufacturer a certain deviation may be expected for each reading. Care was, however, taken to obtain as accurate a reading as possible, and then correlate it with reference to the physical environment before plotting it on the map.

Although the settlement also took place in the savanna areas during Late Iron Age times, during this period the people started to expand into the grassland areas as well (Maggs 1984:204). The identified sites would fall into this period.

The Late Iron Age sites found here conform with those identified by Maggs (1976) for the southern highveld area (southern Transvaal, northern Orange Free State) as Type V sites. These are known to occur as far north as Suikerboschrand and Pretoria, and from this line eastward. However, they have not yet been comprehensively surveyed in this latter area. They originated as part of the Sotho/Tswana settlement of the area and can be dated to the period 1600 - 1850.

As the soil is mostly turf Iron Age settlement usually took place on the various dolorite outcrops. The added benefit of choosing these locations was that it was located at the source of building material used in constructing the settlements.

A few farmsteads dating to early part of this century were identified. Some of these possibly have historical-architectural significance.

A number of abandoned homesteads are located in the areas that were investigated. These seems to belong to farm labourers and were all abandoned within the last few years. They are therefore not viewed to be of cultural or historical significance. However, some graves are located in the vicinity of some of these. It is also possible that more grave will be located close to the various existing homesteads.

Relocation of the graves becomes a matter of obtaining permission from descendants (directly), or by advertising in the newspapers about the pending move. This is followed by permission from the Department of Health of the relevant province, as well as permission from the premier of that province. A commercial firm of undertakers then relocates the graves to a mutually agreed site.

7. ASSESSMENT OF IMPACT

A large number and variety of sites were identified. Fortunately, as mining is mostly to take place below ground, the development would have NO or very LOW impact on the majority of the sites. It is only in the few cases where sites are located in areas that is to be strip mined, or where it is proposed to make the new shafts, that the impact would be HIGH. In this latter regard, the impact would be <u>immediate</u>. Suitable mitigation should therefore take place before any construction starts.

8. RECOMMENDATIONS

5

Based on what was found and its evaluation, it is recommended that the proposed development can continue, but only after suitable mitigation measures for the identified sites and structures are implemented. This consists of:

- 8.1 The relocation of all the graves, their contents and headstones, if they are to be impacted upon by the proposed development.
- 8.2 The archaeological investigation and documentation of the different Late Iron Age sites, especially those that are located in the areas where the shafts are to be made.
- 8.3 The documentation of the various farmsteads, if they are to be impacted upon by the development.
- 8.4 The developers should be notified that archaeological sites might be exposed during the construction work. If anything is noticed, it should be reported immediately to a museum, preferably one at which an archaeologist is available, so that an investigation and evaluation of the finds can be made.
