Umlando was contracted by GAEA Projects to undertake an archaeological survey of the proposed Qwasha Bridge site and associated approach roads. The Southern African National Roads Agency (Pty) Ltd. is responsible for this project. The survey was undertaken on the 27 May 2004. Two sites were recorded on either side of the river; however, no further mitigation is required.

The sites

Site 1 consists of a scatter of Middle Stone Age and a few late Stone Age stone tools. The site will not be affected by the bridge, but may be affected by a road upgrade. The stone tools are in a secondary context and have low archaeological significance.

Site 2 consists of a small scatter of Middle Stone Age stone tools. The stone tools are in a secondary context and have low archaeological significance. The Qwasha Bridge will directly affect this site.

No further mitigation is required for either site.

Southern African National Roads Agency (Pty) Ltd. will need to apply for a permit to damage part of this site(s). The permit is available from KwaZulu-Natal Heritage.

The 1st is part of the main road, the 2nd right is a side-road. Follow the side road until its end at a end circle. There is a current borrow pit beside the beginning of this road, and a smaller track behind it. The upgrade road will follow this track down to the river. The site is at the bottom of the track near the proposed bridge and on the banks of the White Umfolozi.
