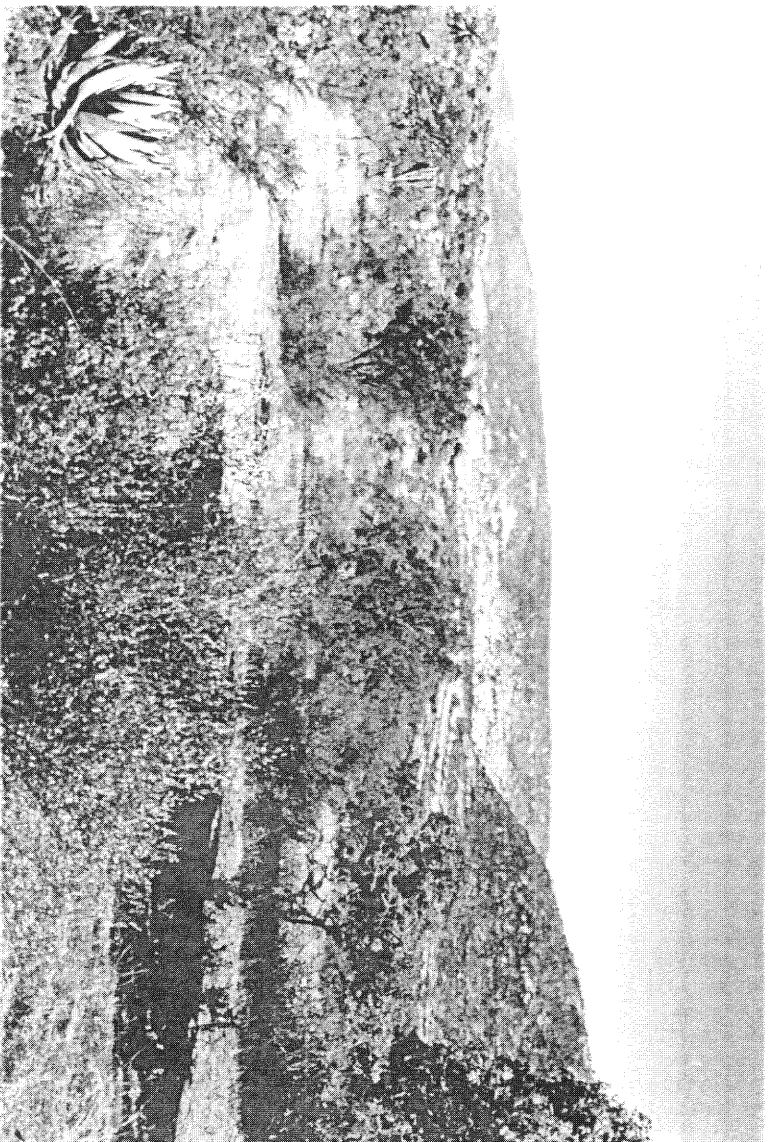

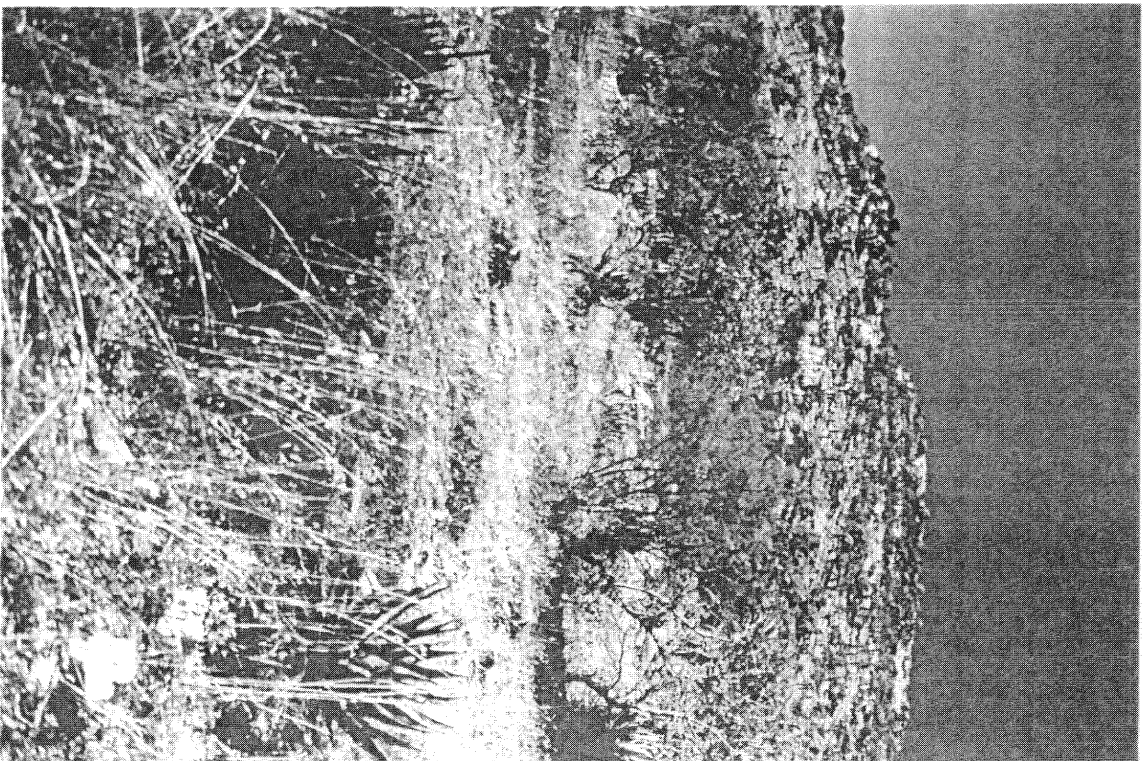


Photograph showing the area for the proposed sites. This photograph was taken facing east.

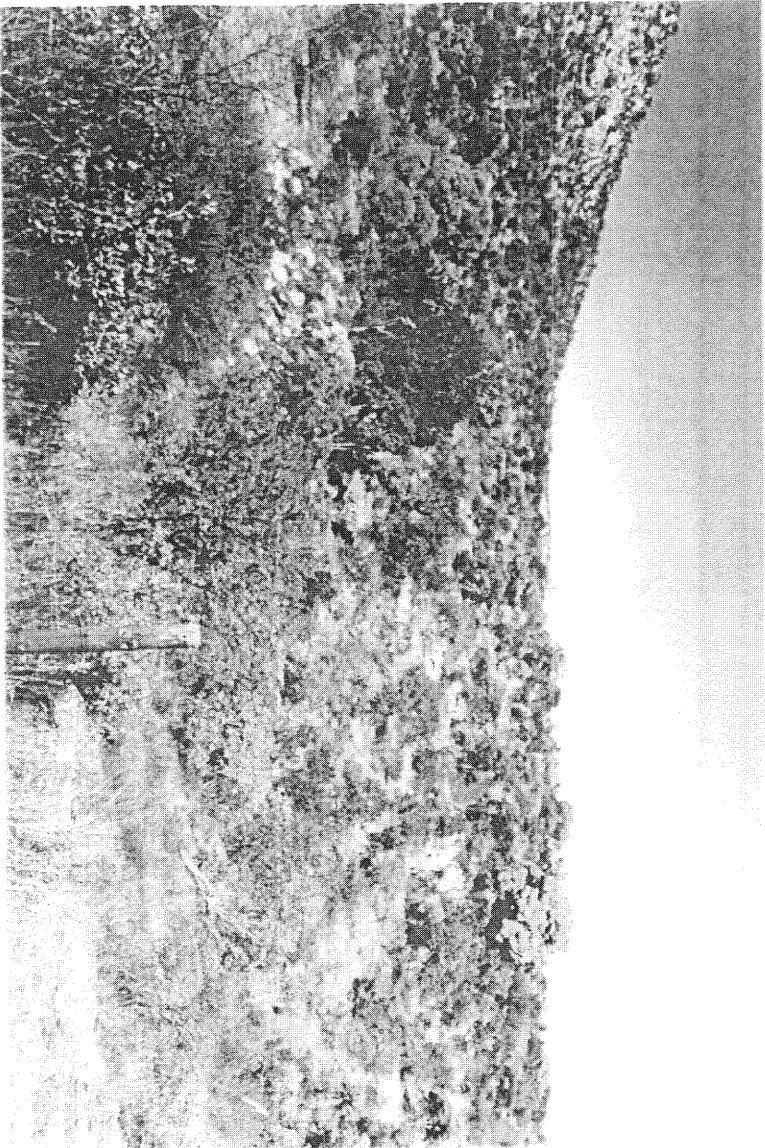


Photograph taken from the proposed site facing south and showing the hill behind the sites.

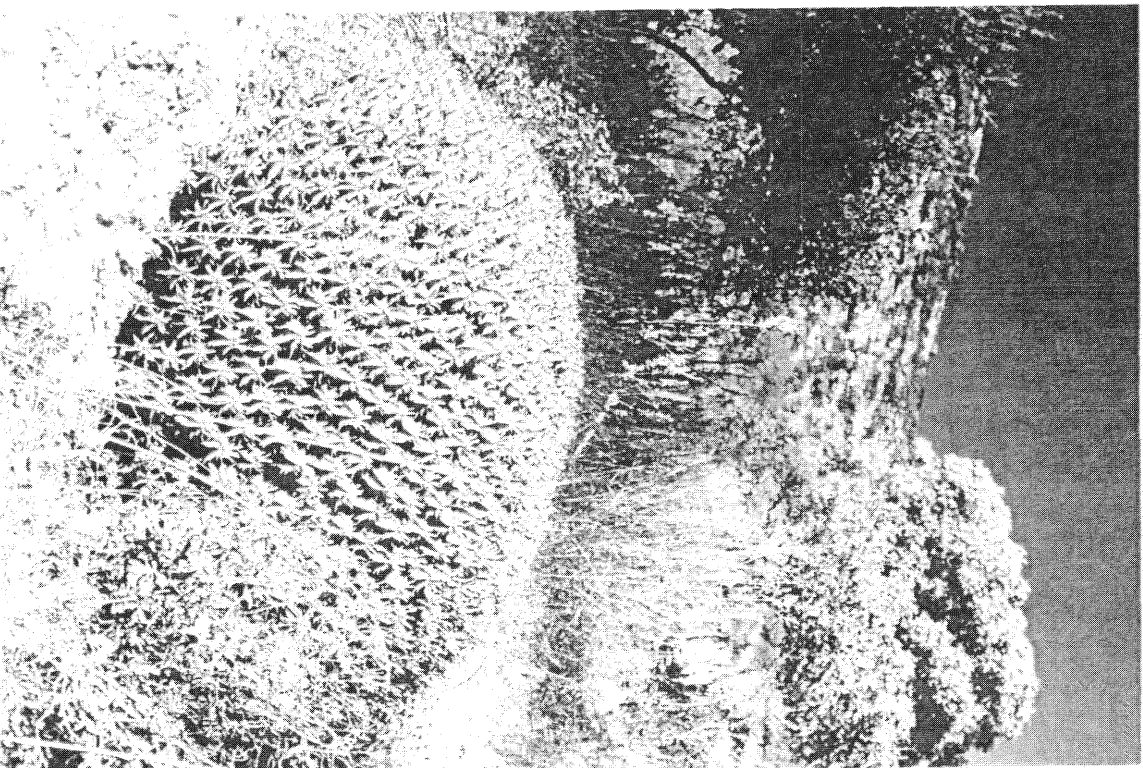


Photograph of Makgeng taken from the existing village showing the view towards the southeast.
