- That, if <u>archaeological material or human remains</u> are uncovered during excavations, The Institute must be contacted immediately in order to determine the significance of the find and mitigation required (a professional archaeologist may need to be employed).
- 6. That a copy of this permit must be kept on site at all times;
- 7. The issuing of this permit does not exempt the Applicant from obtaining the approval of the Local Authority or any other Authority, where required, for the proposed additions and or alterations.

This permit is valid until 17 FEBRUARY 2024 AND IS NOT TRANSFERABLE.




