All archaeological and paleontological Material become, on discovery, the property of the Province of 1.9 KwaZulu- Natal and must be lodged at the repository of KwaZulu- Natal Amafa and Research Institute,

1.10 It is the responsibility of the Applicant to ensure that artefacts are preserved in its original state while in his/her possession;
