BELCom Decision:

The committee responded as follows:

- 1. The comments of the Bo-Kaap Civic Association needs to be submitted.
- 2. A heritage specialist to be appointed to provide a heritage statement which needs to be submitted to this committee, to provide clarity on the following concerns:
 - The exact date of the mosque,
 - Prior uses of the site and building,
 - A photomontage to map the context of the building interior and outstanding features,
 - The height of the next-door building should also be considered as part of the context,
- The committee could not advise on an approach at this stage.
- 4. The heritage statement will determine if the development would be exempted from further and more detailed studies.
- 5. A list of heritage Practitioners would also be provided to assist with the project.
