Notice is hereby given, in terms of the National Environmental Management Act, Act 107 of 1998 (NEMA): Environmental Impact Assessment (EIA) Regulations, 04 December 2014 (as amended on 07 April 2017), Section 41 (2) (a) (b) (c) (d) (e) and (3) published in Government Notices No. R982, under Sections 24 (5) and 44 of NEMA, (as amended on 07 April 2017), of Mbombela Local Municipality's application for an environmental authorisation, to develop a waste transfer station in Matsulu.

Background

The proposed project, involves the construction of a waste transfer station for the Matsulu community, by Mbombela Local Municipality.

Application for environmental authorisation
