Sale of Council Owned Heritage Houses in Bo-Kaap.

We refer to the attached **Notification of Belcom Decision** dated 22 August 2012, setting out the agreed process to be followed regarding the sale of City owned properties in the Bo-Kaap.

20 houses remain to undergo and/or complete this process. Due to a number of tenants not having been able to renovate the subject properties themselves, the City has appointed Messrs Aurecon, to inspect the remaining properties and to report on the current state of repair of these houses. The City intends to carry out the necessary repairs and renovations towards achieving an acceptable housing standard that will allow the properties to be sold to the tenants.

Mr Bossow of Architects Associated, acting as sub consultants to Aurecon, has been appointed to carry out the following documentation:

- 1. Prepare as built drawings for the subject properties
- 2. Prepare building plans for submission to HWC, including Reports for Section 34 applications and to BDM for approval.
- 3. Draw up tasked based specifications with quantities
- 4. Carry out inspections during construction.

It is the intention of the City to carry out the necessary repairs to the houses where required and to carry out minor works and/or alterations and additions for new bathrooms to achieve compliance with NBR. It is not the intention to restore the buildings to their original state, the required interventions are however intended to be carried out in manner that will not detract from the historical character of the buildings within Bo-Kaap.

We hereby submit our Section 34 applications in terms the National Heritage Resources Act on behalf of the City of Cape Town.

Please be advised that we are concurrently submitting this application electronically to SAHRA to obtain their comment, if any, as per the requirement of the Belcom Decision.

RE THE PROPOSED PROCESS TO BE FOLLOWED REGARDING THE CITY OWNED PROPERTIES IN THE BOKAAP

NOTIFICATION OF BELCom DECISION

Consultations between the City of Cape Town (Ms Lisa Stapley) and Heritage Western Cape (Ms Tamar Grover) with regard to the sale of 19 Bokaap properties currently in the ownership of the City refers.

Please be advised that the Motivation Report (undated), the report on Erf 142716, 40 Rose Street, Bokaap prepared by the City's Architectural Branch and the Environmental Resource Management Department, dated May 2012, and the As Built architectural drawings prepared by the City's Architectural Branch, Dwg No A/11-12/001, dated May 2012, all as received by Heritage Western Cape (HWC) on 31 July 2012, were considered by the Built Environment and Landscape Permit Committee (BELCom) at a meeting held on 15 August 2012 (agenda item W12.6).

The matter was tabled at the BELCom to decide if the process agreed to by ourselves was acceptable to the committee and if any additional information or documentation should be included in subsequent submissions to HWC with respect to the subject properties.

DECISION

Upon consideration of the aforementioned documentation the Committee supported the proposed process and recommended that consultation with SAHRA be included (i.e. that SAHRA be given the opportunity to comment on the proposed process given that the Bokaap is a Grade 1 area). HWC insists that the City of Cape Town ensure that no work be carried out (to the subject properties) without HWC approval.

Further to the above, HWC requires an application to be made for any/all work proposed to be undertaken to any/each of the subject buildings. Hence, a Section 34 application will need to be made for alterations/additions to 40 Rose Street, and any/each of the subject properties, for proposed new work, that is work not as yet undertaken to said property/properties.

HWC thus looks forward to continued consultations with The City in this regard for the remaining properties and awaits advisement that SAHRA has been consulted vis-à-vis the BELCom decision. It may be beneficial for the
