Letter of Recommendation for Exemption (LoRE)

1. Introduction

Mediro Association is proposing the construction of 6 poultry houses with the capacity to hold up to 10 000 birds per house on Portion 44 (portion of portion 27 of the farm Lanric 59 JO situated in Ngaka Modiri Molema District Municipality within the Mahikeng Local Municipality area, North West Province. The proposed project triggers a Basic Assessment for certain listed activities under Listing 1 (GNR 327) and Listing 3 (GNR 324) of NEMA (National Environmental Management Act, 1998). Bucandi Environmental Solutions (Bucandi) was requested by Mediro Association to conduct a Basic Assessment as part of the application for environmental authorisation.

2. Project description and location

The activity will entail the construction of 6 environmentally controlled chicken layer houses (70m x 6m each). Each house will have the capacity for 10 000 layers. The entire site will be able to house up to 60 000 birds. The farm boundary is 1.5ha and the development site boundary is 9 838.40m2.

The project will entail the following:

- Earthworks and clearing of vegetation (0.9ha of indigenous vegetation) on the site for 6 poultry houses.
- Construction of 6 environmentally controlled chicken houses (70m x 6m) with capacity for 10 000 birds per house, totalling 60 000 birds.
- A silo and water tank will be erected next to each house.
- Powerlines will be connected to each house from the existing Eskom point.
- Pipelines will be connected to each house from an existing borehole.
- The site will be fenced off with a 2.4m high electric fence.

The study area is located 2km west of Mahikeng in the Northwest Province within the Mahikeng Local Municipality area and Ngaka Modiri Molema District Municipality, North West Province. A secondary road between Slurry (south) and Bewley (north) runs directly next to the site with a dirt road providing access to the site.




Figure 1: Regional context of the survey site, located east of Mahikeng




Figure 3: Location of the survey site east of Mahikeng




Figure 4: Location of the survey footprint as indicated on the 1:50 000 map 2525DC (1996)

4. Site assessment and observations

The one hectare site is located adjacent to a dirt track, east of an existing Drive-in-theatre and situated west of a burrow pit (excavations). The site was covered in grass and medium bushes and trees until recently. However the site has been completely cleared of surface brush in early 2020. According to the SAHRIS database the nearest heritage sites are a graveyard (Site ID. 39834) and an assemblage of artefacts (Site ID. 39833) approximately 2 km north-west of the site. Most of the surroundings areas have been either cleared of ploughed during the recent past and no indications of heritage remains in the area are currently known. No historical structures or events are associated with the specific site.

4. Recommendation

It is therefore recommended that the proposed construction of six poultry houses on portion 44 (portion of portion 27) of the farm Lanric 59 JO be allowed to continue.
