

# NOTIFICATION

We hereby give notice to you as the owner/occupier of the land below that Eskom Distribution intends to construct a proposed Matsheketsheeni 132kV Substation and Turn-In Lines to the existing Parklands/Vlaaklagte 132kV Line. Matsheketsheeni 132/11kV 20MVA new substation establishment will help deload Blaauwbosch(Blaauwbosch NB03) and Vlaklaagte substation(Vlaklaagte NB42, NB43, NB45 and NB46), that will create spare capacity on Blaauwbosch and Vlaklaagte networks, it will also pick up some electrification load. Matsheketsheeni SS will deload about 12MVA from Vlaklaagte and Blaauwbosch substation.

In terms of section 5(a) of the **Eskom Conversion Act** 13 of 2001, prior notice is hereby given that Eskom Holdings SOC Limited will enter the property mentioned below, presently occupied by you, by means of its officers, employees or agents in order to make plans, surveys and installation of towers and conductors.

Whilst conducting the survey, a grave was discovered. The neighbours informed Eskom that the grave owners relocated long time ago. Eskom Land & Rights department through Land & Rights officer endeavoured to contact the grave owners, but was unsuccessful as their whereabouts are unknown.

Please note that:

- The grave is 25 meters away from Substation boundary.
- Eskom/Contractor will visible barricade the grave site during construction process.
