

### G. HISTORICAL BACKGROUND INFORMATION

The proposed development fall under Dr. Ruth Segomotsi Mompati District municipality. Although the district municipality is famous for housing the Taung World heritage site, various other heritage resources have been recorded and documented across it. The district is rich in both tangible and intangible heritage materials, providing a broad history of the area. Overall, the greater North West Province has been intensively studied and the research yielded several archaeological sites of world importance (Wardley 1996).

The cultural landscape qualities of the region consist of two components. Firstly, is the rural area, where the human occupation comprises a pre-colonial (Stone Age and Iron Age) occupation and a much later colonial (farmer) component. The second component is an urban one consisting of several smaller towns, most of which developed during the last 150 years or less. Parts of the district have abundant evidence gathered from various areas (for example, caves and rock shelters). These archaeological artifacts are documented through Heritage Impact Assessments and academic research; for example, see Stammers (2017) and Caruna et al. (2021). These have recorded several artefacts belonging to all the archaeological periods, i.e., the Stone Age, Iron Age, and the Historical Era.

As far as earlier wars or conflicts is concerned, the Dr. Ruth Segomotsi Mompati District Municipality has a rich history dating back to the 1880s. For instance, it has been documented that some of the first white settlers arrived at Stella (a now small cattle farming town) in the Naledi Local Municipality in 1882. Some of the earlier conflicts include that of the white settlers who fought the baTlhaping under chief Mankurwane and the Korana or Kora under King Mosweu around 1880s. King Mosweu was said to have been occupying the area along the hill of Maamusa on the banks of the Harts River, while chief Mankurwane's group was occupying the area between Vaal and Harts river (South African History Online).

It is documented that the indigenous Koranas and baTlhaping, in which, this time around, the Boers and British provided aid to each of the two groups, were fighting over access to natural resources, including fuelwood and grazing. As a result, the Boer Republic of Stellaland was established in 1883. And later, a Schweizer-Reneke town (situated in Mamusa Local Municipality) was founded on 1 October 1888 (South African History Online). Evidence of some of the wars or conflicts fought between the locals and settlers and signs of earlier settlements are now documented (in SAHRIS databases) or presented in burial grounds, monuments, and memorials across the districts. However, some of the native African history or movement is not included in the SAHRA; for example, the movements of Mzilikazi in the 1830s, who was one of King Shaka's generals who moved in the north of what is now called Zeerust thereafter migrating to Zimbabwe in 1937 (Rasmussen 1977;

Boeyens 2003).

Morokweng Village was established during the first segregation law passed by the Union Parliament in 1913 (Act No. 27 of 1913). The law prohibited whites from buying land from Africans and vice versa. This law created the Morokweng Native Reserve, which was proclaimed on June 19, 1913 and was part of the Vryburg District in the Cape Province. (SA story 2017). The village was led by Piet Setlhabetsi as headman at the Konki village from 1921 to 1933 when he passed on. There is evidence that he did an excellent job and was repeatedly rewarded with increased subsidies from the government. Ten years later after his death, Setlhabetsi Tshokho was elected as the new headman of the village and appointed in 1943. His conviction for stealing stocks relieved him of his duties in December 1943 and a new headman named Johnny Piet Setlhabetse was appointed early in 1944. The Morokweng Tribal Authority was established in 1957. The Commissioner for Bantu Affairs at the time noted that the chairman and members of the Reserve Board were strong supporters of the government who never caused difficulties due to the lack of lower educational facilities in the village Morokweng Municipality took over to design the school in the early 1950s and to build. Over the years the school has been refurbished to address student safety concerns, eventually changing from the original design

Due to lack of lower educational facilities in the village, the community of Morokweng took it upon themselves to design and construct the school in the early 1950s. Over the years the school was renovated or refurbished to accommodate the safety aspect for the learners, which eventually changed the original design of the school. Early this year the parents of the learners took it upon themselves to protest against their children going to the school based on its dilapidated state and demanded that the department of education build a new school for their children (Taung news 2022). Site inspection of the school facilities indicated that indeed the school was damaged and posed to be dangerous to the health and safety of both the teachers and learners.
