Phase I Survey: Paternoster ERF 26

Background and Introduction

Since the Vredenburg Peninsula has been attractive to prehistoric peoples for well over 100,000 years, there is a need to identify sites which will be adversely affected by proposed construction projects.

Kasteelberg (some 4km inland from Paternoster) has been identified as the major locus for early herding activities in the Vredenburg Peninsula (see Smith, 1987 -- enclosed). This particular building proposal potentially will affect one of the main sources of marine products for Kasteelberg. The site in question is the Eerste Mosselbank, excavated by A.B. Smith in 1987. Three radiocarbon dates bracketed the midden deposit between 2880 ± 60 and 2590 ± 50 B.P. The midden and its artifacts relate to the preherder deposits of Kasteelberg 'C' site, dated to 2160 ± 50 B.P.

Other excavations in the Paternoster area (Robertshaw, 1977 --enclosed) indicate continued occupation of the coast after 2000 B.P.

Paternoster ERF 26

Development of the coast between the village of Paternoster and the Eerste Mosselbank is proposed. ERF 26 has been divided into 72 residential plots by the present owner, Mr. Snyman (map 1).

The previous owners, Paternoster Vissery Bpk., 10th Floor Pier House, Herengracht 8001, under the direction of the Managing Director, Mr. A.G.J. Koegelenberg (021) 419-3280 have already cleared and flattened the site without an environmental impact assessment.

The Survey


Survey of the proposed development area could only take place on its edges, since the area, as mentioned above, had already been bulldozed flat and straw deposited on the surface. In flattening the area they have damaged the edge of the mega-midden of Paternoster North A (map 2) which extends inland from the Eerste Mosselbank. No other sites were recognised within the boundaries of the proposed construction area.

Recommendations


The mega-midden at Eerste Mosselbank is an important archaeological site and needs to be protected. In order that further damage be avoided a fence should be erected on the N.E. boundary corner around plot 252, as marked on the maps.

Once the fence has been erected I see no reason why building should not begin, but careful monitoring of the site should take place to ensure the contractors do not damage the area outside the fence.
