My qualification and experiences are as follows:

2.1 I am in possession of the following:

2.1.1. Bachelors of Arts (BA) majoring in Social Anthropology and Archaeology;

2.1.2 Bachelors of Science Honours (BSc Hons) in Physical Anthropology;

2.1.3 Bachelors of Science Honours (BSc Hons) in Archaeology obtained from the University of the Witwatersrand and the University of Pretoria respectively.

2.2 I have over 1 year practical experience in forensic anthropology and 5 years practical experience in archaeological fieldwork.

In the performance of my official duties on 2016-05-17, I was informed of the skeletal remains found during an excavation next to the drive way of a residence in Montana Gardens, Pretoria North by Captain Makuwa attached to the Pretoria North Detectives, who requested Victim Identification Center for assistance with an exhumation.

In the performance of my official duties on 2016-05-17, Lieutenant M Motaung, Warrant Officer C S August, Warrant Officer A C Hagg attached to Victim Identification Center and I, travelled to Pretoria North to conduct an exhumation at 95 Jan Riebeeck Street

with GPS coordinates 25°41'14.66"S 28°10'37.87"E, as pointed out by Captain Makuwa.

Upon arrival on the scene the skull was already exposed and some ribs and phalanges were found on the stockpile that was excavated. It was noted that the remains were archaeological and therefore could not be further exhumed prior to attaining a permit from the South African Heritage Resources Agency.

During the course of my official duties 2016-05-17, the skull was uncovered and placed into 1x evidence sealing bag with number PW3000779481, marked inter alia "Pretoria North Date:2016-05-17" which I then sealed. From the date of uncovering the skull until now, the skull is under safe keeping

I know and understand the contents of this declaration.


I have no objection to taking the prescribed oath.
