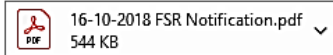

REGISTERED INTERESTED AND AFFECTED PARTY NOTIFICATION: AVAILABILITY OF THE DRAFT ENVIRONMENTAL IMPACT ASSESSMENT AND ENVIRONMENTAL MANAGEMENT PROGRAMME REPORT

Waterberg JV Resources (Pty) Ltd applied for a Mining Right for the proposed Waterberg Platinum Mine in terms of the Mineral and Petroleum Resources Development Act 28 of 2002 ("MPRDA") to the Department of Mineral Resources ("DMR") on 30 August 2018. Waterberg JV Resources also applied for Environmental Authorisation in terms of the National Environmental Management Act 107 of 1998 ("NEMA") and the 2014 Environment Impact Assessment ("EIA") Regulations (as amended) as well as for a Waste Management Licence in terms of the National Environmental Management: Waste Act 59 of 2008 ("NEMWA"), which was acknowledged on 6 September 2018. The Final Scoping Report was submitted to the DMR on 15 October 2018 and was accepted by the DMR on 14 January 2019.

A request for an extension for submission of the Final Environmental Impact Assessment and Environmental Management Programme Report ("EIA/EMPR") in terms of 23(1) (b) of the EIA Regulations was submitted on 24 January 2019, and accepted on 14 February 2019, providing the applicant an additional 50 days. The primary reason for the request for an extension of time was to provide time for further consultation with Interested and Affected Parties ("IAPs"). A further request for an extension for submission of the final EIA/EMPR in terms of Regulation 3(7) of the EIA Regulations was submitted to the DMR on 24 April 2019 and accepted on 10 May 2019. The primary reason for the second request for an extension of time was due to an expansion of the scope of work to investigate in more detail the placement of infrastructure on the Farm Ketting 368 LR ("Ketting"), as a possible preferred alternative.

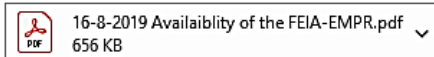
