Umlando undertook its monthly archaeological survey of the Zulti North Mining lease on 06 May 2009. One new site was recorded. Several previously recorded sites were also re-visited. Our previous survey occurred on the 31 March, and it was difficult to survey in April due to the many public holidays and prior commitments. We were not too concerned about the surveys as Mining Ponds C, D and E were all still busy with the very high dunes and would not have gone that much further. This was confirmed during the survey where only MPE had some dune clearance.

**MPE 89:** 

MPE 89 is located on the first dune cordon from Lake Nhlabane, at the top of a dune. It occurs on both sides of the track. The site consists of at least three shell patches consisting mainly of brown mussel. There are a lot of WBS fragments lying about, as well as pottery rims. All the pottery is undecorated. Several ugs's occur on the surface, also bovid bone, daga, slag and possible human bone.

Significance: The site is of medium significance.

Mitigation: The site will be monitored for possible human remains.

We did notice that a bulldozer had cleared an area adjacent to MPE77. We have undertaken preliminary excavations at this site and have rated the site as having high significance in terms of preservation of material and duration of occupation. We intend to excavate the site this month and then for a few weeks thereafter. We have informed RBM Rehab. Regarding the bulldozer, and have placed poles with red paint (a sign for "no-go" area) as well as a sign stating that there is an archaeological site across the only access path. In addition to this, we will meet with RBM Rehab. personnel to demarcate the site my clearly.
