




MAP OF RELATIVE AGRICULTURE THEME SENSITIVITY

MAP OF RELATIVE ANIMAL SPECIES THEME SENSITIVITY




MAP OF RELATIVE DEFENCE THEME SENSITIVITY


MAP OF RELATIVE PALEONTOLOGY THEME SENSITIVITY
