Project locality:

The local jurisdiction of the proposed activity will fall under Mbombela Local Municipality, in Matsulu. The nearest towns include Nelspruit which is the biggest town (44km away from Matsulu) which is located West from proposed site, Kaapmuiden (5km) which is located North of Matsulu, Mpakeni (17km) which is located North West from Matsulu, Kanyamazane (25km) which is located North West from Matsulu and Tekwane (40km) which is located North West from Matsulu. Additional towns and settlements include: Maelalane, Luphisi and Daantjie. The proposed project, involves the construction of a waste transfer station in the Matsulu community of Mbombela, by Mbombela Local Municipality. The construction of the transfer station is part of municipality's integrated waste management strategy, that looks to develop waste transfer stations for the towns of Mbombela, which also includes White River, Hazyview, and Kabokweni. The waste will then be hauled from the transfer stations to the Tekwane West Central Waste Disposal Site (CWDS).

Notice is hereby given in terms of the National Environmental Management Act, Act 107 of 1998 (NEMA): Environmental Impact Assessment (EIA) Regulations, 2014 R982 (2014 EIA Regulations), Section 41 (2) (a) (b) (c) (d) (e) and (3) published in Government Notices No. R982, under Sections 24 (5) and 44 of NEMA, (as amended on 07 April 2017) of Mpumalanga Local Municipality's intention to undertake Environmental Impact Assessment Studies - in the form of Basic Assessment Report (BAR) for the proposed development of the proposed Waste Transfer Station within the Mbombela Local Municipality, in Mpumalanga province.

The Mbombela Local Municipality has appointed a team comprising of engineers and environmental experts to undertake and compile supporting documentation for the environmental authorisation application. 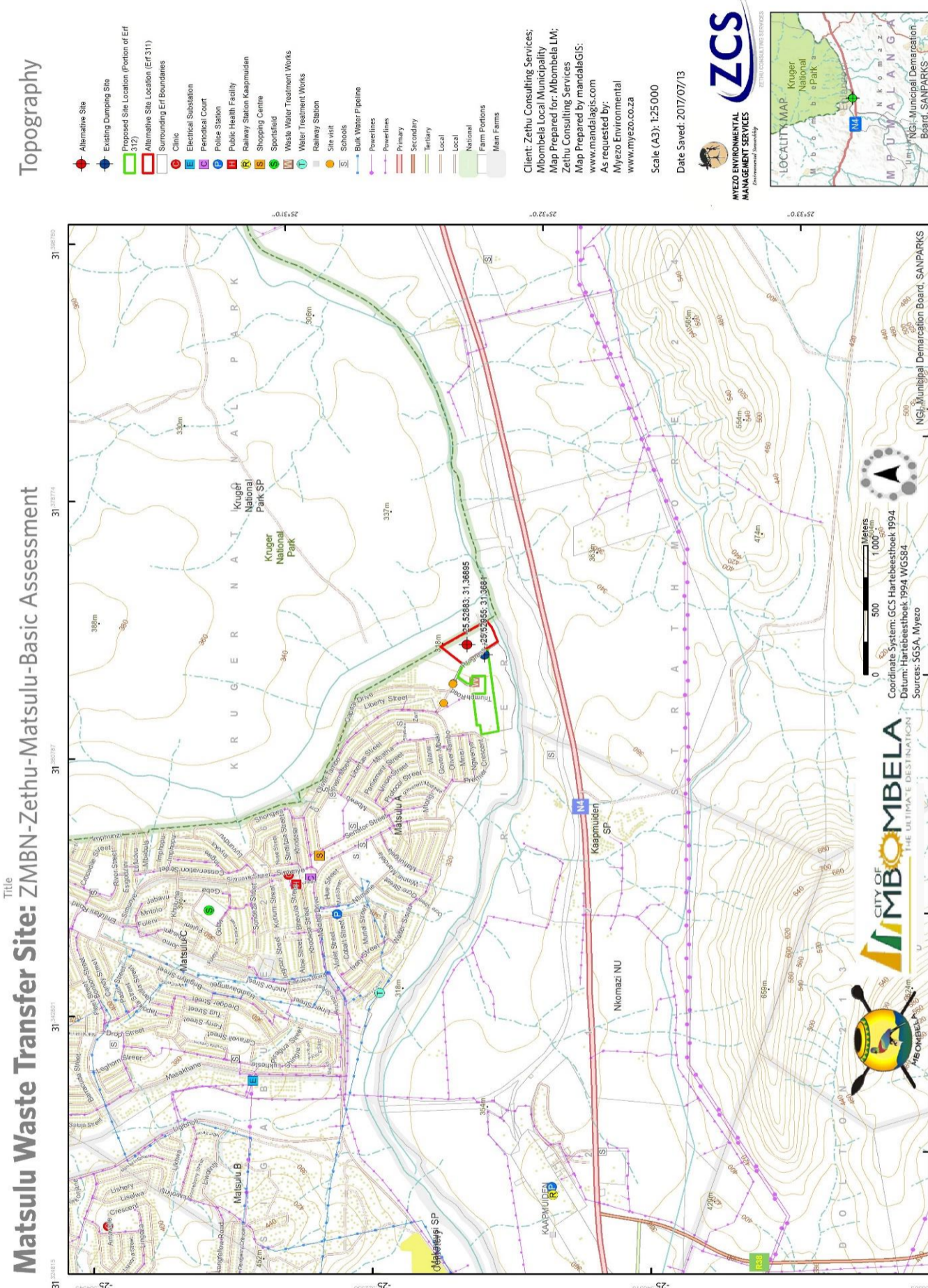
