APPLICATION FOR A PROSPECTING RIGHT IN TERMS OF SECTION 16 OF THE MINERAL AND PETROLEUM RESOURCES DEVELOPMENT ACT, 2002 AS AMENDED BY SECTION 12 OF ACT 49 OF 2008 AND ENVIRONMETAL AUTHORIZATION IN TERMS OF NATIONAL ENVIRONMENTAL MANAGEMENT ACT, 1998 (ACT 107 OF 1998) AS AMENDED: PORTION OF THE REMAINDER PLOT 2100 CONCORDIA, REMAINDER AND PORTION 2 OF THE FARM GEZELSCAP BANK NO 71, REMAINDER AND PORTION 1 OF THE FARM EENDOP NO 69, PORTION

OF THE REMAINDER, PORTION OF PORTION 2 AND PORTION OF PORTION 4 OF THE FARM NAIP NO 68: SITUATED WITIN ADMINISTRATIVE DISTRICT NAMAQUALAND

- 1. This is to inform you that your application for a prospecting right in terms of section 16 of the Mineral and Petroleum Resources Development Act, 2002 (Act 28 of 2002) ("Act") as amended and the Environmental Authorization in line with NEMA Regulations for Antimony, Bismuth, Chrome, Cobalt, Copper Ore, Gold Ore, Heavy Minerals, Iron, Lead, Molybdenium, Monazite, Nickel, Phosphate, Platinum Group Metals, Pyrite, Rutile, Silver, Sulphur, Sulphur in Pyrite, Tin, Vanadium, Zinc Ore and Zirconium has been accepted.
- Kindly note that minerals Berylium, Lithium, Niobium, Rare Earths and Tantalum have been excluded from this application, since there is an accepted application lodged by Flagsship Lifestyle (Pty) Ltd for the same mineral under reference number NC 30/5/1/1/2/12757 PR.
- 3. Further note that Pamish Investments No 65 (Pty) Ltd is the holder of a prospecting right to prospect for Uranium in respect of the farms Naip No 68, Eendop No 69, Kontorogab No 72, Kweekfontein No 73 and Kaitob No 74 and should be consulted as interested and affected party.
- 4. In terms of section 12 (d) of the Act, you are directed to comply with the following instructions:
 - a. Upload on to SAMRAD system and Submit the relevant environmental reports required in terms of chapter 5 read with Regulation 19(1) of the National Environment Management Act, 1998.

b. Notify and consult with the landowner, lawful occupier and any interested and affected party and include the result of the consultation in the environmental reports in line with Regulation 41(2) read with Section 24J of National Environment Management Act, 1998.

c. Lodge an application in terms of National Water Act, 1998 (Act 36 of 1998) with the Department of Water Affairs with immediate effect.

5. Further note that the acceptance of your application does not grant you the right to commence with prospecting activities. It only signify that your application will be processed, evaluated and the Minister or his delegate will make a decision within 197 days from the date of lodgement of your application.
