APPLICATION FOR PROSPECTING RIGHT IN TERMS OF SECTION 16 IN TERMS OF THE MINERAL AND PETROLEUM RESOURCES DEVELOPMENT ACT, 2002 (THE ACT) (AS AMENDED: PORTIONS 1 AND 88 OF THE FARM HOLGATFONTEIN 326 IR: IN THE MAGISTERIAL DISTRICT OF NIGEL.

 - d. Your articles and memorandum of association
4. Acceptance of your application does not grant you the right to commence with any prospecting and/or mining activities. It only signifies that your application will be processed in order for the Minister or his delegate to consider same and make a decision within **197 days** from the date of acceptance of your application.
