AMENDMENT OF THE ENVIRONMENTAL AUTHORISATION ISSUED ON 15 MARCH 2018 FOR THE PROPOSED 235MW HARTEBEESLEEGTE WIND ENERGY FACILITY (WEF) AND ASSOCIATED INFRASTRUCTURE SITUATED NEAR LOERIESFONTEIN, WITHIN THE HANTAM LOCAL MUNICIPALITY IN THE NORTHERN CAPE PROVINCE

The Environmental Authorisation (EA) issued for the abovementioned application by this Department on 15 March 2018, the first amendment to the EA dated 22 May 2019, the second amendment to the EA dated 04 March 2020, and your application for amendment of the EA received by the Department on 18 June 2021 and the acknowledgement letter dated 28 June 2021 as well as the additional information received on 02 July 2021 refers.

Based on a review of the reason for requesting an amendment to the above EA, this Department, in terms of Chapter 5 of the Environmental Impact Assessment Regulations, 2014 as amended, has decided to amend the EA dated 15 March 2018 as amended, as follows:

# Amendment 1: Inclusion of a battery energy storage system (BESS)

The BESS will comprise of multiple battery (Lithium-ion) units or modules housed in shipping containers and/or an applicable housing structure which will be **delivered pre-assembled** to the project site. The BESS will cover an area of 4ha and will be located within the authorised on-site substation footprint of the 235 MW Hartebeesleegte Wind Energy Facility and therefore, no clearing of vegetation beyond the original authorised development footprint, and threshold will be required.

## Reasons for the abovementioned amendments:

The purpose of the BESS is to store excess electrical output from the wind farm as it is generated and to allow for a timed release of electricity output to the grid during periods of high electricity demand. The use of the BESS will enable the project to dispatch energy from the wind farm as and when it is required, which will minimise energy losses. The holder of the EA, the project name and description, technical details of the facility, and change in Condition 16.2 (page 8 of the EA) needed to be amended to include/ reflect the new associated infrastructure, namely BESS.

This proposed amendment letter must be read in conjunction with the EA dated 15 March 2018 as amended.

In terms of the Promotion of Administrative Justice Act, 2000 (Act No 3 of 2000), you are entitled to the right to fair, lawful and reasonable administrative action; and to written reasons for administrative action that affects you negatively. Further your attention is drawn to the provisions of the Protection of Personal Information Act, 2013 (Act no. 4 of 2013) which stipulates that the Department should conduct itself in a responsible manner when collecting, processing, storing and sharing an individual or another entity's personal information by holding the Department accountable should the Department abuses or compromises your personal information in any way.

In terms of Regulation 4(2) of the Environmental Impact Assessment Regulations, 2014, as amended (the EIA Regulations), you are instructed to notify all registered interested and affected parties, in writing and within 14 (fourteen) days of the date of the EA, of the Department's as well as the provisions regarding the submission of appeals that are contained in the Regulations.

Your attention is drawn to Chapter 2 of National Environmental Management Act, 1998 (Act No. 107 of 1998) National Appeal Regulations published under Government Notice R993 in Government Gazette No. 38303 dated 08 December 2014 (National Appeal Regulations, 2014), which prescribe the appeal procedure to be followed. Kindly include a copy of this document (National Appeal Regulations, 2014) with the letter of notification to interested and affected parties in this matter.

Should any person wish to lodge an appeal against this decision, he/she must submit the appeal to the appeal administrator, and a copy of the appeal to the applicant, any registered interested and affected party, and any organ of state with interest in the matter within 20 days from the date that the notification of the decision was sent to the registered interested and affected parties by the applicant; or the date that the notification of the decision was sent to the applicant by the Department, whichever is applicable.


