AMENDMENT OF THE ENVIRONMENTAL AUTHORISATION ISSUED ON 10 JANUARY 2017 (AS AMENDED) FOR THE CONSTRUCTION OF THE 50MW DE WILDT PHOTOVOLTAIC PARK TO BE ESTABLISHED ON PORTION 15, 27 AND 28 OF THE FARM SCHIETFONTEIN 437 JQ WITHIN THE MADIBENG LOCAL MUNICIPALITY IN THE NORTH WEST PROVINCE

The Environmental Authorisation (EA) issued for the above application by this Department on 10 January 2017, your application for amendment of the EA received by this Department on 02 November 2018 and the acknowledgement letter dated 09 November 2018, refer.

Based on a review of the reason for requesting an amendment to the above EA, this Department, in terms of Chapter 5 of the Environmental Impact Assessment (EIA) Regulations, 2014, as amended, has decided to amend the EA dated 10 January 2017 as follows:

The applicant applied to increase the width of the access road from 6m to 8m in order to ensure the safety of large construction vehicles. Given that the western access road has been routed to avoid the delineated watercourse, the road is no longer straight and includes several curves. The additional width is required to ensure that large construction vehicles are able to navigate the revised geometry of the road. Large construction vehicles have a large turning circle, and the additional road width is required to ensure that they will be able to navigate the curve of the access road without driving off the designated road surface. In addition, the requested increase in width will ensure that large construction vehicles are able to pass each other safely.

In terms of the Promotion of Administrative Justice Act, 2000 (Act No 3 of 2000), you are entitled to the right to fair, lawful and reasonable administrative action; and to written reasons for administrative action that affects you negatively. Your attention is drawn to Chapter 2 of National Environmental Management Act, 1998 (Act No. 107 of 1998) National Appeal Regulations published under Government Notice R993 in Government Gazette No. 38303 dated 08 December 2014 (National Appeal Regulations, 2014), which prescribe the appeal procedure to be followed. Kindly include a copy of this document (National Appeal Regulations, 2014) with the letter of notification to interested and affected parties in this matter.

Should any person wish to lodge an appeal against this decision, he/she must submit the appeal to the appeal administrator, and a copy of the appeal to the applicant, any registered interested and affected party, and any organ of state with interest in the matter within 20 days from the date that the notification of the decision was sent to the registered interested and affected parties by the applicant; or the date that the notification of the decision was sent to the applicant by the Department, whichever is applicable.
