ENVIRONMENTAL AUTHORISATION IN TERMS OF SECTION 24 OF THE NATIONAL ENVIRONMENTAL MANAGEMENT ACT, ACT 107 OF 1998 TO UNDERTAKE A LISTED ACTIVITY AS SCHEDULED IN THE ENVIRONMENTAL IMPACT ASSESSMENT REGULATIONS, 2014, AS AMENDED: ACCESS ROADS AND WATERCOURSE CROSSINGS WITHIN THE AUTHORISED IZIDULI EMOYENI WIND ENERGY FACILITY, WITHIN THE BLUE CRANE ROUTE MUNICIPAL AREA.


