AMENDMENT OF THE ENVIRONMENTAL AUTHORISATION ISSUED ON 08 AUGUST 2014 FOR THE 75MW PV3 PHOTOVOLTAIC ENERGY FACILITY ON THE REMAINDER OF PORTION 4 OF THE FARM NO. 177 KLIPHGATS PAN NEAR COPPERTON, SITUATED WITHIN THE SIYATHEMBA LOCAL MUNICIPALITY NORTHERN CAPE

The applicant applied to amend the property description of the EA so that it correlates with the property description in the title deed for the affected property.

Amendment 3: Amendment to extend the validity period of the EA:

The activity must commence within a period of three (03) years from the date of expiry of the EA issued on 08 August 2014 (i.e. the EA lapses on 08 August 2020). If commencement of the activity does not occur within that period, the authorisation lapses and a new application for environmental authorisation must be made in order for the activity to be undertaken.

The applicant applied to extend the validity period of the EA as the development was not awarded preferred bidder status in the DoE REIPPPP. The applicant intends to bid this project in the DoE REIPPPP future rounds.

This amendment letter must be read in conjunction with the EA dated 08 August 2014.

In terms of Regulation 4(2) of the Environmental Impact Assessment Regulations, 2014 (the Regulations), you are instructed to notify all registered interested and affected parties, in writing and within 14 (fourteen) days of the date of the EA, of the Department's decision in respect of your application as well as the fact that an appeal may be lodged against the decision in terms of the National Appeals Regulations, and the provisions regarding the submission of appeals as contained in the Regulations.

Should any person wish to lodge an appeal against this decision, he/she must submit the appeal to the appeal administrator, and a copy of the appeal to the applicant, any registered interested and affected party, and any organ of state with interest in the matter within 20 days from the date that the notification of the decision was sent to the registered interested and affected parties by the applicant; or the date that the notification of the decision was sent to the applicant by the Department, whichever is applicable
