**ACCEPTANCE OF AN APPLICATION FOR A PROSPECTING RIGHT IN TERMS OF SECTION 16 OF MPRDA ACT 2002 , (ACT 28 OF 2002) AS AMENDED BY AMENDMENT ACT , 2008 (ACT 49 OF 2008 )TO DLAMINI FAMILY TRUST ON THE FARMS KROMDRAAI 265 KR, SITUATED IN THE MAGISTERIAL DISTRICT OF MOGALAKWENA.**

I refer to the abovementioned matter and confirm that your application for a prospecting right for **Chrome, Cobalt, Gold, Iron, Nickel, PGM, Silver, Vanadium** in terms of section 16 of MPRDA Act has been accepted.

**In terms of Section 16(4) of MPRDA Act, 2002 (Act 28 of 2002) as amended by amendment 2008 (Act 49 of 2008) you are therefore required to submit the following:**

- (a) to consult the Department of Land Affairs if it the is state-owned land , in the event the land is subject to land restitution consult office of the Commission of Land Rights and submit the result of such consultation to this office on or before the **12 December 2018 (30 days)**.
- (b) **You are requested in terms of Section 17(4) of the Act to give effect to the object referred to in Section 2(d) of the Act. In this regard, you are required to submit by no later than the 07 February 2018 the following documents:**
  - duly signed shareholders agreement;
  - share certificates and shareholder's registers;
  - articles and memorandum of association of the company;

- details relating to funding (all relevant agreements); and
- any other agreement or documents relating to the agreement.

Acceptance of your application does not grant you the right to commence with prospecting operations. Your application will be evaluated / processed and a recommendation on the granting / refusal of the right will be forwarded to the Minister or her delegate. Any person operating without a prospecting / mining right or mining permit will be in contravention of Section 5(4) of the MPRDA and would be guilty of an offence in terms of the relevant Act.

Should it transpire at later stage that the area under application is encumbered by an old order right, the Department will be entitled to refuse this application based on the fact that an old order right for the same minerals, has already been granted to another entity, as the granting thereof would be contrary to the provisions of the Minerals and Petroleum Resources Development Act, 2002 (Act 28 of 2002).
