# Recording and reporting to the Department

- 1.24 The holder of the Authorisation must submit an environmental audit report to the Department within thirty (30) days upon completion of the construction and rehabilitation activities. The environmental audit report must –
  - 1.24.1 Be compiled in accordance with Appendix 7 of the 2014 EIA Regulations as amended and must indicate the date of the audit, the name of the auditor and the outcome of the audit in terms of compliance with the EA conditions as well as the requirements of the approved EMPr.
  - 1.24.2 Be kept on site and be made available for inspection by any relevant and competent authority in respect of this development.

# Commencement of the activity

- The authorised activity shall not commence within twenty (20) days after the EA has been issued by the Department to allow the appeal process to proceed accordingly.
- 1.26 Should you be notified by the MEC of a suspension of the EA pending appeal procedures, you shall not commence with the activity unless authorised by the MEC in writing.

## Notification to authorities

Fourteen (14) days prior written notice must be given to the Department that the activities will commence. Commencement for the purposes of this condition includes site preparation. Operation of the activity

1.28 Fourteen (14) days prior written notice must be given to the Department that the activities

will commence with the operation.

Site closure and decommissioning

Should the activities ever cease or become redundant, the applicant shall undertake the

required actions as prescribed by legislation at the time and comply with all relevant legal

requirements administered by any relevant and competent authority at that time.

1.30 Before decommissioning of the development becomes evident a rehabilitation plan must

be compiled and should be approved by this Department.

Specific conditions

An integrated waste management approach that is based on waste minimisation must be

implemented and must incorporate reduction, recycling, re-use and disposal where

appropriate. Any solid waste shall be disposed of at a landfill licensed in terms of section

20 (b) of the National Environment Management Waste Act, 2008 (Act No. 59 of 2008)

as amended.

1.32 Effort must be made to ensure that preventative actions are taken that any water bodies

present on and around the site will not be negatively impacted by the commencement of

this activity.

The development of the primary assessment area can proceed provided that all landfill

activities are restricted to within the boundaries of the development footprint as per the

palaeontological heritage assessment.

1.34 It is recommended that representative numbers of individuals/clusters of the identified

provincially protected species be adequately relocated to other suitable and similar areas

as to where they were removed from prior to commencement of any vegetation clearance

or construction activities and a provincial flora permit must be obtained runent of Economic, Small Business Development, Tourism and Environmental Affairs

1.35 A sufficient stormwater cut-off berm/trench must be constructed on the upstream side

directly adjacent outside and along the northern and eastern boundaries of the

assessment area.

This cut-off berm must prevent clean surface water runoff from entering the proposed

development footprint area by diverting and channeling surface water runoff around the

footprint area towards the south-west for dispersal.

The cut-off berm must ensure clean/dirty water separation on site as well as ensuring

continued flow within the local and broader quaternary surface water catchment and

drainage area in order to maintain its ecological functionality and integrity.

The upstream and downstream boreholes must be drilled to establish the baseline

ground water quality as well as to be used for ground water monitoring.

1.39 The proposed site must be lined in order to ensure no leaching of pollutants into the

subsurface occurs.

1.40 During construction of the landfill, the gravel from this area must be compacted to at least

95% of MOD AASHTO in order to reduce porosity.

Access to the proposed site must be gained through the provincial road, R48 only and

the applicant must adhere to all the conditions provided by the Department of Police,

Roads & Transport.

1.42 The applicant must ensure that he obtain the required licenses from the Department of

Water and Sanitation as well as from the Provincial Department of Environmental Affairs

(DESTEA) prior commencement of the proposed new waste disposal site.

1.43 The applicant must ensure that the fire breaks exist around the perimeter fencing.

1.44 The applicant must adhere to all the recommendations provided within the Technical and

Specialist reports.

Annexure 1: Reasons for Decision

1. Background

The applicant, Letsemeng Local Municipality, applied for an Authorisation to commence with activity 15 of Listing Notice 2 (GNR 325) of the 2014 EIA Regulations as amended, described in the Final Environmental Impact Assessment Report (EIAR) dated 31 January 2022, for the proposed new waste disposal site to be carried out on the remaining extent of Portion 1 of the Farm De Dorpsgronden 577.

The applicant appointed NSVT consultants to undertake Environmental Impact Assessment process for the activities as required by Regulation 21 of the 2014 EIA Regulations as amended.

2. Information considered in making the decision

In reaching its decision, the Department took, *inter alia*, the following into consideration -

a) The listed activity as applied for in the application form received on 13 July 2021.

b) The information contained in the Final Environmental Impact Assessment Report (EIAR) dated 31 January 2022 completed by NSVT Consultants.

c) Comments received from the interested and affected parties as included in the Final Environmental Impact Assessment Report dated 31 January 2022.

d) Mitigation measures as proposed in the Final EIAR dated 31 January 2022 and the EMPr.

e) The information contained in the specialist studies contained within the appendices of the Final EIAR dated 31 January 2022.

f) The objectives and requirements of relevant legislation, policies and guidelines and Section 2 of the National Environmental Management Act, 1998 (Act No. 107 of 1998).

g) The findings of the site visit were undertaken by Ms. An Mogorosi from the Department on

the 17<sup>th</sup> of May 2022.

3. Key factors considered in making the decision

All information presented to the Department was taken into account in the Department's consideration of the application. A summary of the issues which, in the Department's view, were

of the most significance is set out below:

a) Details provided of the qualifications of the Environmental Assessment Practitioner (EAP)

indicated the EAP is competent to carry out the Environmental Impact Assessment

procedures.

b) The findings of all the specialist studies conducted and their recommended mitigation

measures.

c) The need for the proposed development of the new waste disposal site.

d) The Final EIAR dated 31 January 2022 identified all legislation and guidelines that have

been considered in the preparation of the EIAR.

e) The methodology used in assessing the potential impacts identified in the Final EIAR

dated 31 January 2022 and the specialist studies have been adequately indicated.

f) A sufficient public participation process was undertaken and the applicant has satisfied

the minimum requirements as prescribed in the 2014 EIA Regulations as amended for

public involvement.

g) Recommendations made by the EAP in the Final EIAR, feasible and reasonable

alternative options including the no-go were investigated as part of the assessment

process.

- (b) The identification and assessment of impacts are detailed in the Final BAR dated 31 January 2022 and sufficient assessment of the key identified issues and impacts have been completed.
- (c) The procedure followed for impact assessment is adequate for the decision-making process.
- (d) The proposed mitigation of impacts identified and assessed adequately curtails the identified impacts.
- (e) EMPr measures for the pre-construction, construction, operation and rehabilitation phases of the development were proposed and included in the Final BAR and will be implemented to manage the identified environmental impacts throughout the life span of the project.
- (f) Adequate process in line with law and legislation for public participation process was undertaken and the EAP has met the minimum requirements as prescribed in the 2014 EIA Regulations as amended.

In view of the above, the Department is satisfied that, subject to compliance with the conditions contained in the Environmental Authorisation, the proposed activities will not conflict with the general objectives of integrated environmental management laid down in Chapter 5 of the National Environmental Management Act, 1998 (Act No. 107 of 1998) and that any potential detrimental environmental impacts resulting from the proposed activities can be mitigated to acceptable levels, therefore the application is accordingly granted.
