1. Background

The applicant, Harmony Gold Mining Co Ltd, applied for an Authorisation to commence with activities 1(i), 11(i), 12(ii)(a)(c), 14, 19, 27 of Listing Notice 1 (GNR 327) and activities 4(b)(i)(gg), 10(b)(i)(gg)(hh), 12(b)(i), 14(ii)(a)(c)(b)(i)(hh) of Listing Notice 3 (GNR 324) of the 2014 EIA Regulations as amended described in the Final Basic Assessment Report (BAR) dated 06 October 2022. The proposed development of a 14 MW Harmony Central Plant Solar Photovoltaic (PV) Facility and related infrastructure on portion 12 of the farm Saaiplaas 771 and portion 1 of the farm Rustgevonden 564, in Virginia, Matjhabeng Local Municipality, Free State Province.

The applicant appointed **Savannah Environmental (Pty) Ltd** to undertake Environmental Impact Assessment process for the activities as required by Regulation 21 of the 2014 EIA Regulations as amended.

f) The objectives and requirements of relevant legislation, policies and guidelines and Section 2 of the National Environmental Management Act, 1998 (Act No. 107 of 1998).

g) The findings of the site inspection were undertaken by Mr. Tlotliso Hanong from the department on 18 January 2023.

3. Key factors considered in making the decision

All information presented to the Department was taken into account in the Department's consideration of the application. A summary of the issues which, in the Department's view, were of the most significance is set out below:

- a) Details provided of the qualifications of the Environmental Assessment Practitioner (EAP) indicated the EAP is competent to carry out the Environmental Impact Assessment procedures.
- b) The proposed development will benefit the local community through job creation, skills development opportunities, and training which will, in turn, assist in reducing the poverty levels that the area is currently facing, and indirectly strengthen the electricity supply for the area.
- c) The Final BAR dated 06 October 2022 identified all legislation and guidelines that have been considered in the preparation of the BAR.
- d) The methodology used in assessing the potential impacts identified in the Final BAR dated 06 October 2022 have been adequately indicated.
- e) A sufficient public participation process was undertaken and the applicant has satisfied the minimum requirements as prescribed in the 2014 EIA Regulations as amended for public involvement.
- f) Recommendations made by the EAP in the Final BAR, feasible and reasonable alternative options including the no-go were investigated as part of the assessment process.

that any potential detrimental environmental impacts resulting from the proposed activities

can be mitigated to acceptable levels, therefore the application is accordingly granted.
