COMMENTS ON DRAFT BASIC ASSESSMENT REPORT FOR DREDGING, EXCAVATION AND REMOVAL OF SOIL FROM A WATERCOURSE TO CONSTRUCT A BRIDGE IN BORAKALALO VILLAGE, RAMOTSHERE MOILOA LOCAL MUNICIPALITY, NORTH WEST PROVINCE

The Draft Basic Assessment Report received by the Department on 23 July 2020 refers.

- Project description on page 3 of the application form and the report does not say anything about the listed activity
 applied for, please rephrase the project description to incorporate listed activity number 19 (i).
- Furthermore, listed activity must be correctly cited as it appears in the Regulations, for instance, activity 19 (i) of Government Notice Number R. 327 and the correct classification sector for any activities within or close to watercourse must be ticked.
- Activity number 21 of Government Notice Number R.327 must be removed from the activities being applied for, as it is the mandate of the Department of Mineral Resource, therefore the application for borrow pit must be lodged with Department of Mineral Resources.
- Page 8 of the application form indicating whether application fee has been paid or not the correct answer must be ticked.
- Responsible Heritage Resources Authority must be notified about the project in terms of Section 38 (1) (c) (i) of National Heritage Resources Act, 1999 (Act No 25 of 1999) and proof that the consultation was made must be attached in the report.

- Basic Assessment Report must be compiled as per Appendix 1 of Government Notice Number R. 326 and it must be in colour, not black and white.
- The Environmental Management Programme (EMPR) must be compiled as per Appendix 4 of Government Notice Number R. 326.
- The content of the report and EMPR does not give any information about the listed activity applied for [activity 19 (i)]. You are requested to incorporate information related to activity 19 (i) in the report and EMPR; the impacts, risks, mitigations measures, etc.
- The Department is not satisfied about the quality and presentation of the draft Basic Assessment Report
 Please take note that BAR is a legal document, therefore it must be accurate, consistent and comprehensive
 and must be an original document.
- Please take note: providing incorrect or misleading in any form, including any document submitted in terms of these Regulations (2014 EIA Regulations) to a competent authority (DEDECT) is an offence in terms of Regulation 48 (1) (a) of GN. No. R. 326.
