**4.2.** The said amount should be either in a form of bank guarantee issued

by any South African registered bank or cash deposit into DME

Rehabilitation Trust Account (Account No. 40 6703 4181 ABSA

Bank).

**4.3.** Conduct phase 1 of Heritage Impact Assessment to determine if there

are any archaeological or paleontological found on sites which will be

impacted by the proposed prospecting activities as required by

National Heritage Resources Act (NHRA No 25 of 1999).

3. You are therefore requested to upload the requested information to comply with the

minimum requirements of National Environmental Management Act, 1998 (as

amended) (NEMA) and the Environmental Impact Assessment (EIA) Regulations,

2014.

commence without an Environmental Authorisation.
