The proposed project relates to the development of a retirement village on Holdings 19-23 and 48, known as Wilkoppies Extention 108. The portion of land to be development is completely surrounded by urban development. According to the report submitted the area is flat and disturbed by past agricultural activities and illegal dumping. The author notes that large sections of the property has been cleared although dense vegetation occurs in some sections.

Even though the development is situated in an urban context, five sites of heritage significance were identified during the survey. It should be noted that SAHRA specifically requests that all reports compiled after September 2012 contain track-paths of the area surveyed. No reports will be accepted in future if no track-paths are indicated.

Stone Age

The author describes Site 1 as a scatter of Middle/Later Stone Age artefacts of low density and significance. The author notes the possibility of the discovery of further stone age material, but suggests that these may not be in context.

Recent Structures

The author describes Site 2 as the remains of foundations of recent structures that is less than 60 years of age. It is noted that these structures have mainly been demolished. Since they are younger than 60 years of age they are not protected in terms of the National Heritage Resources Act.

Historical Remains and Refuse Midden

The author notes that Sites 3-5 are possibly related to each other. The author suggested that the Site 3 (the midden) could date to between the late 19th century and mid 20th century. It is not not clear if the author means the site to date to the late 19th century and was used up unto the mid-20th century, or if it can date to anywhere between the late 19th and mid-20th century.





Sites 4-5 are foundations of structures that relate to Site 3 but as with the midden, the dates of these two sites are not well understood and may be contemporaneous. However, these foundations are considered to be of low significance.

From the map provided in the Memorandum uploaded with the case, it appears that the access road to the village will certainly affect Sites 3, 4 and 5.

Final Comment:

SAHRA does not require any further assessment for Site 1, Site 4 and Site 5.

A Phase 2 assessment may be required for Site 3 (the midden). However, since the significance of the site is not properly addressed and explained in the report, SAHRA requires that the archaeologist responsible for the mitigation submit an application for a permit in terms of section 35 of the National Heritage Resources Act (Act no 29 of 1999) to SAHRA. This application will be inclusive of a fully comprehensive motivation which highlights the significance of the sites and the rationale for its sampling and excavation.

If Sites 3-5 are younger than 100 years but 60 years or older the decision will have to be referred to the North West Provincial Heritage Resources Authority (Mr Mosiane Mothlabane, tel. 018 388 2826, email: mosianem@nwpg.gov.za).
