PERMIT

Issued under Section 35(4) of the National Heritage Resources Act, Act No. 25 of 1999. Permission is hereby given:

- to: Dr. M. Chazan in association with Mr. D. Morris,
- of: the Department of Anthropology, University of Toronto, 19 Russell Street, Toronto, ONT M5S 2S2 and the Archaeology Department, McGregor Museum, Atlas Street, Kimberley, South Africa,
- for: excavation in order to collect well-provenanced archaeological samples to characterize the lithic assemblage and nature of deposition; to sample for OSL dating,
- at: Bestwood 1, at approximately 27.6826S, 23.09090E,
- on: the farm Bestwood, near Kathu,
- in: the John Taolo Gaetsewe District Municipality, Northern Cape Province.

The following conditions apply:

- 1. If the permit holder is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorised representatives.
- 2. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be used. Note that the position of all excavations must be marked on a plan of each site.
- 3. A standard site record form must be lodged with the McGregor Museum.
- 4. All material collected and excavated, as well as field notes and records, will be curated by the McGregor Museum.
- 5. A progress report must be submitted to SAHRA on or before 01 August 2012 and 01 August 2013 and a final report is due on or before 01 August 2014. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory.
- 6. Reprints of all published papers, or copies of theses or reports resulting from this work must be lodged with SAHRA.
- 7. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
- 8. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
- 9. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of SAHRA and the landowner.
- 10. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
- 11. SAHRA reserves the right to cancel this permit by notice to the permit holder. This permit is valid until 01 August 2014
