Issued under Section 35(4) of the National Heritage Resources Act, Act No. 25 of 1999.
Permission is hereby given:

to: Mr W Fourie in association with Dr M van der Ryst and Ms J Behrens,,
of: the PGS Heritage & Grave Relocation Consultants, 906 Bergarend Street, Waverley East, 1086 and UNISA,
for: mapping and surface collection of archaeological material at sites DS001 (Tower DN217), a Middle Stone Age site, and DS002 (Tower DN233), a Colonial period site, that will be directly impacted by the proposed 400kV Dinaledi-Spitskop transmission line,
on: Portion 4 of the farm Nietgedacht 242 JQ, and Portion 239 of the farm Hartbeespoort 419 JQ,
in: the Rustenburg District, North-West Province.

The following conditions apply:

1. If the permit holder is not to be present on the site at all times then SAHRA must be provided with the names and qualifications of the authorised representatives.
2. Adequate recording methods as specified in the Regulations and Guidelines pertaining to the National Heritage Resources Act must be used. Note that the position of all excavations must be marked on a plan of each site.
3. A standard site record form must be lodged with the Ditsong Museum.
4. All material collected and excavated, as well as field notes and records, will be curated by the UNISA.
5. Human remains are ethically sensitive, where these are accidentally discovered during this phase 2 exercise, all the necessary consultations, as may be required by NHRA, must be done.
6. This permit does not apply to any associated development activities to the project which were not assessed as part of the phase 1 HIA of this project.
7. No sites may be destroyed without a permit from SAHRA
8. A report must be submitted to SAHRA on or before 01 October 2012. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory.
9. Reprints of all published papers, or copies of theses or reports resulting from this work must be lodged with SAHRA.
10. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
11. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
12. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of SAHRA and the landowner.

13. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
14. SAHRA reserves the right to cancel this permit by notice to the permit holder.

This permit is valid until 01 October 2012.
