TEMPORARY EXPORT PERMIT

Issued under Sections 32 and 35(4) of the National Heritage Resources Act, Act No. 25 of 1999. Permission is hereby given:

to: Dr J Neveling (ID: 7209025078080),

of: the Council for Geoscience, Private Bag X112, Pretoria, 0001,

for: the temporary export of five specimens of the parareptile *Eunotosaurus africanus*. The samples are: Specimen M777 which consists of the skull and two vertebrae (~2.5 cm), Specimen M71 which consists of postcranial material (6 cm long), Specimen M275 which consists of postcranial material (24 cm long), Specimen M776 which consists of post cranial material (14 cm long), Specimen CM86/341 of postcranial material (15 cm in length) which consists of the anterior end of the vertebral column with six sets of partially preserved, broadened ribs...

from: the Geoscience Museum located at the Transvaal Museum (Ditsong Museum), 432 Paul Kruger Street, Pretoria,

to: Dr J Gauthier,

of: the Division of Vertebrae Palaeontology, Yale Peabody Museum of Natural History, Yale University, 170 Whitney Avenue, New haven, CT 06511, USA,

for: morphological study and CT scanning as well as thin sectioning of one of the ribs of the *Eunotosaurus* specimen for further study.

The following conditions apply:

- 1. The objects or specimens must be clearly marked with accession numbers.
- 2. The material must be carefully packed and all packaging must be clearly marked with the accession numbers, the name of the site, and the name and address of the permit holder or the Council for Geoscience.
- 3. The material must be hand carried or sent via a reputable professional courier service unless written instructions to the contrary have been received from the repository, Council for Geoscience.
- 4. The material may not be loaned to any person or institution other than Dr J Gauthier without the consent of SAHRA.
- 5. The material shall be returned to South Africa on or before 01 July 2012 at the expense of Dr J Gauthier.
- 6. SAHRA must be notified in writing of the return of the material, and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before 01 July 2012.
- 7. Copies of all papers or publications resulting from this permit must be lodged with SAHRA.
- 8. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
- 9. SAHRA reserves the right to cancel this permit by notice to the permit holder.
- 10. This permit is subject to a general appeal and may be suspended should an appeal against the decisions be received by SAHRA within 14 days from the date of the permit. SAHRA may not be held responsible for any costs or losses incurred in the event of the suspension or retraction of this permit.
