EXPORT PERMIT

No. 80/09/05/003/52

Issued under Sections 32 and 35(4) of the National Heritage Resources Act, Act No. 25 of 1999.
Permission is hereby given:

to: Dr M Chazan & Mr D Morris,
of: the Department of Anthropology, University of Toronto, 100 St George Street, Toronto,
Ontario, M5S1A1, and McGregor Museum, P.O. Box 316, Kimberley, 8300,
for: the temporary export of :

- 3 cosmogenic isotope dating samples, (Wonderwerk Cave loose sediment from Excavation 6) for analysis by Ari Matmon; Hebrew University, Israel;
- 30 palaeomagnetic dating samples, each 1 cm³ sediment from Wonderwerk Cave for analysis by Hagai Ron, Hebrew University, Jerusalem;
- 40 grain-size analysis sediment samples from Wonderwerk Cave, for analysis to determine the source of material for cave deposit and 3 OSL samples, ca 500 g. Wonderwerk Cave sediment, for analysis/dating by Naomi Porat, Israel Geological Survey, Israel,
- 10 bone samples, all non-diagnostic splinters, ca 10 g., from Wonderwerk Cave for FTIR analysis by Paul Goldberg, Boston University, USA, to determine whether the bones are burnt.

for: the permanent export of:

- 10 non-diagnostic flakes/flake fragments for petrographic analysis from Kathu Pan 1, 5 each from St.4a and St.4b (MMK Loan form 666). These will be photographed before analysis by Michael Chazan,
- 5 non-diagnostic flakes for petrographic analysis, Kathu Townlands (MMK Loan form 666); several ostrich eggshell samples, Wonderwerk Cave MSA and lower levels (MMK Loan 666) and 2 chert flakes, Wonderwerk Cave, Excavation 6, to Michael Chazan for cosmogenic isotope analysis. These will be photographed before export.
- 7 (up to 9) micromorphology blocks ca 400 cm³, Wonderwerk Cave sediment (MMK Loan 666) for analysis of site formation processes by Paul Goldberg, Boston University, USA, 50% of each block will be returned to the McGregor Museum;

- 27 (up to 40) stalagmite samples from Excavations 1 & 2 Wonderwerk (MMK Loan 666) for U-Th & U-Pb and isotopic analysis (dating and paleaeoclimate) for analysis coordinated by Naomi Porat. All samples will be photographed and sectioned before analysis; 50% of each sample will be returned to the McGregor Museum;
- from: Wonderwerk Cave, Kathu Pan and Kathu Townlands, Northern Cape Province,
to: Ari Matmon, Hagai Ron, Naomi Porat and Paul Goldberg (as noted above) care of Michael Chazan,
of: Dept of Anthropology University of Toronto 100 St George Street Toronto, Ontario MSS1A1 Canada.

The following conditions apply:

1. The objects or specimens must be clearly marked with accession numbers.
2. The material must be carefully packed and all packaging must be clearly marked with the accession numbers, the name of the site, and the name and address of the permit holder or the McGregor Museum.
3. The material must be hand carried or sent via a reputable professional courier service unless written instructions to the contrary have been received from the repository, McGregor Museum.
4. The material may not be loaned to any person or institution other than Mr M Chazan (and those noted above) without the consent of SAHRA.
5. The material that shall be returned to South Africa (as noted above) must be returned on or before 01 July 2010 at the expense of Mr M Chazan.
6. SAHRA must be notified in writing of the return of the material, and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before 01 July 2010.
7. Copies of all papers or publications resulting from this permit must be lodged with SAHRA.
8. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
9. SAHRA reserves the right to cancel this permit by notice to the permit holder.
10. This permit is subject to a general appeal and may be suspended should an appeal against the decisions be received by SAHRA within 14 days from the date of the permit. SAHRA may not be held responsible for any costs or losses incurred in the event of the suspension or retraction of this permit.

This permit is valid until 01 July 2010.
