- 5. The material shall be returned to South Africa on or before 01 June 2012 at the expense of Dr F Senegas.
- 6. SAHRA must be notified in writing of the return of the material, and a report on the activities undertaken in terms of this permit must be lodged with SAHRA before 01 June 2012.
- 7. Copies of all papers or publications resulting from this permit must be lodged with SAHRA.
- 8. SAHRA shall not be liable for any losses, damages or injuries to persons or properties as a result of any activities in connection with this permit.
- 9. SAHRA reserves the right to cancel this permit by notice to the permit holder.
